CLEANSING NOTICE

Notice under section 708A(5)(e) of the Corporations Act 2001 (Cth)

Peako Limited ("Peako") (ASX Code PKO) has yesterday issued 33,333 fully paid ordinary shares at an issue price of A\$0.015 (1.5 cents) as part of a promotion and marketing initiative.
