**FIRST TRANCHE ISSUED TO CORNELL CAPITAL PARTNERS AND NEW
PLACEMENT OF 2,000,000 SHARES RAISING \$84,000 BEFORE COSTS
AGREEMENT TO ISSUE FURTHER 8,333,333 SHARES**

The Company has today issued 2,044,189 shares in the first of five tranches to Cornell Capital Partners as announced on 21 September 2004. The price per share was \$0.0489192.

A new placement was also made today of 2,000,000 shares at \$0.042 per share to a professional client of The Venture Group Limited raising \$84,000 which will be used for working capital and to advance the Goondicum Industrial Minerals Project.

The directors have also reached an agreement to issue a further 8,333,333 shares at \$0.042 to professional clients of The Venture Group Limited.

The Company seeks to rely on case 1 in Section 708A(5) of the Corporations Act ("Act") in respect of the issue of those placement shares.

The Company gives notice under paragraph (5) (e) of Section 708A of the Act to confirm that:
