ISSUE OF UNQUOTED OPTIONS AND CLEANSING PROSPECTUS SHARES

Hawkstone Mining Limited (“the Company”) advises that pursuant to the Notice of Annual General Meeting lodged with ASX on 3 November 2020 and the subsequent approval by Shareholders at the Annual General Meeting held on 2 December 2020, the Company issued the following unquoted options on 2 December 2020:

- 194,444,445 unquoted Placement Options exercisable at \$0.02 each on or before 2 December 2022; and
- 15,000,000 unquoted Broker Options exercisable at \$0.02 each on or before 2 December 2022,

(“Options”).

There was no consideration payable on the Options. Full details are set out in the Notice of Meeting lodged with ASX on 3 November 2020.

The Company also advises that pursuant to the cleansing prospectus dated 5 November 2020 (“Cleansing Prospectus”), the Company closed the offer and issued 100 shares under the Cleansing Prospectus on 3 December 2020.
