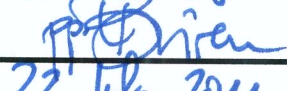
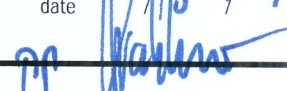

DIRECTIONS
