PolarX Limited (ASX:PXX, "the Company") advises that it has issued 337,837 ordinary shares ("Shares") as part consideration for the amendments to the Company's option to acquire an interest in the Caribou Dome Project in Alaska USA (refer further ASX announcement of 17 November 2020).
