## QuickFee extends closing date of SPP

**QuickFee Limited (ASX:QFE)** (“QuickFee”) advises that the closing date of the Share Purchase Plan (SPP) announced on 17 and 18 September 2020 (and the terms of conditions of which were announced on 28 September 2020) will be extended by 48 hours to 5:00 pm (AEDT), Wednesday, 14 October 2020. The extension will ensure that all eligible shareholders have additional time to participate in the SPP, considering the delays to the postage of the SPP booklet and application form, particularly in Melbourne due to the COVID-19 restrictions.

Eligible shareholders wishing to participate in the SPP who have not yet received their SPP booklet and application form are advised to email [info@quickfee.com.au](mailto:info@quickfee.com.au) and provide their registered holding name, holder identification number (HIN), registered address and contract number.

All other terms of the SPP remain the same and are set out in the terms and conditions contained in the SPP booklet.

### Issue price

As a result of the extension of the closing date, the issue price for each new share under the SPP will be the lower of:

- (a) the issue price paid under the September 2020 share placement, being A\$0.58; and
- (b) the price that is a 5% discount to the volume weighted average price (VWAP) of ordinary shares in QuickFee traded on the ASX over the 5 trading days up to, and including, the day on which the SPP closes (Wednesday, 14 October 2020).
