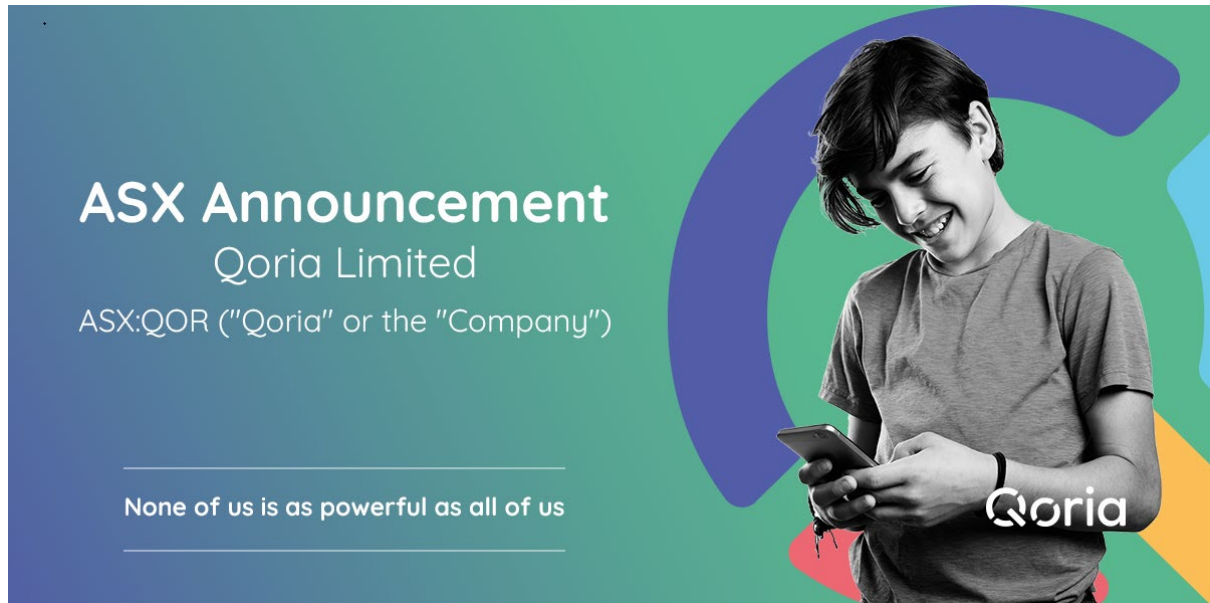




SHARE ISSUE AND CLEANSING STATEMENT
