CHANGE OF AUDITORS

INCOMING AUDITOR

Reckon Limited ("Reckon" or the "Company") announces that BDO Audit Pty Ltd ("BDO") have been appointed as the Company's auditors with effect from today, 24 November 2021.

OUTGOING AUDITOR

This appointment follows the resignation of Deloitte Touche Tohmatsu (ABN 74 490 121 060) ("DTT") and ASIC's consent to this by email from ASIC dated 23 November 2021 approving such resignation.

REASONS FOR CHANGE

The decision for the change was made for commercial reasons.

The Company confirms that upon receipt of DTT's intention to resign, conditional upon ASIC's consent, it undertook a tender process and assessed various applications against its criteria and ultimately chose BDO.

In accordance with section 327(c) of the Corporations Act 2001, a resolution will be tabled at the Company's Annual General Meeting in May 2022 to ratify the appointment of BDO as the Company's auditors.
