The exchange rate for the dividend to holders of CDIs trading on the Australian Securities Exchange (ASX) will be 0.7780 U.S. dollars for 1.00 Australian dollar. The dividend to be paid in Australian currency to CDI holders will be 0.0450 Australian dollar per CDI. The default U.S. withholding tax deducted from dividends to Australian residents is 30%. However, in accordance with the existing tax treaty between the U.S. and Australia the withholding tax rate can be decreased to 15% if the appropriate form (e.g. Form W-8BEN-E or Form W-8BEN) is submitted by the beneficial owner of the Australian CDIs to our Australian Share Registry, Computershare Investor Services Pty Limited.

A dividend of USD 0.35 per share was declared for holders of ResMed's common stock trading on the New York Stock Exchange. Holders of Chess Depositary Instruments (CDIs) trading on the Australian Securities Exchange will receive an equivalent amount in AUD, based on the exchange rate on the record date, and reflecting the 10:1 ratio between CDIs and NYSE shares.
