SUCCESSFUL PLACEMENT OF REMAINING TRANCHE OF RIGHTS ISSUE SHORTFALL

Select Exploration Limited (ASX: SLT) ("**Select**" or "**the Company**") is pleased to announce that, following the renounceable pro-rata offer of up to 83,109,074 Shares at an issue price of \$0.01 under the Prospectus dated 26 June 2013 ("**Rights Issue**"), which raised \$212,195.52, and the First and Second Tranches of the Shortfall Placement which raised \$593,895.22, the Company has successfully placed the remaining tranche of the Shortfall Placement from the Rights Issue to raise a further \$25,000 and complete the Shortfall Placement.

The Company confirms the remaining tranche of the Shortfall Placement shares have now been issued, being 2,500,000 fully paid ordinary shares at \$0.01 per share to raise \$25,000.00 (before costs) ("**Third Tranche**").

Please refer the attached Appendix 3B in this regard. The Shortfall Placement was made under Exception 3 of ASX Listing Rule 7.2, being an issue to make up the shortfall on a pro-rata issue to holders of ordinary securities.

The total capital raised under the Rights Issue and the three tranches of the Shortfall Placement was \$831,090.74.
