Vesting of the Rights occurred over three annual vesting dates and also subject to performance conditions during each of the performance periods ending on 30 June 2013, 30 June 2014 and 30 June 2015 and subject to meeting the eligible person condition. Rights will lapse at the earlier of the date that the board determines that the performance hurdles have not been satisfied, 3 months from the date of cessation of employment/engagement or 30 June 2019.
