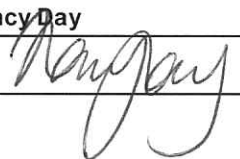

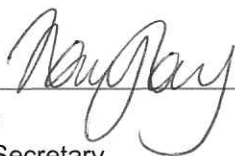

DIRECTIONS

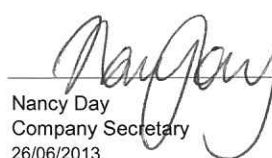
