Please find attached an Appendix 3B relating to the issue of 8.5 million employee options at an exercise price of \$1.40 per share expiring on or before 11th August 2019.

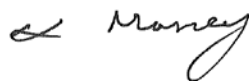
In addition the Company is proposing to issue 1.5 million employee options to the Company's Managing Director – Mark Clark, subject to shareholder approval on the same terms as above.

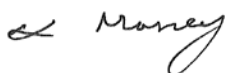
