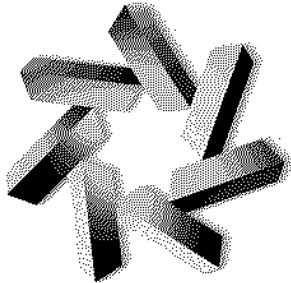



DIRECTIONS


