Employee Share Scheme Shares

I am pleased to advise that HGL has issued 100,000 HGL shares (Scheme Shares) under the HGL Employee Share Scheme (Scheme). These shares have been issued to our acquisitions manager, Tony Holley, in recognition of the importance of that role to the continued growth of HGL.

The issue price of the shares was \$2.1768 per share and in accordance with the terms of the Scheme a loan (Scheme Loan) has been made to Tony Holley to enable him to acquire the shares. The shares are subject to conditions designed to encourage Mr Holley to remain with the Company. In this respect, the shares that have been issued are subject to the condition that Mr Holley remain employed by the Company for not less than three years from the issue date. If, at any time that Mr Holley ceases to be an employee for any reason other than death, any of his Scheme Shares are subject to a condition that has not been satisfied, those Scheme Shares will be immediately bought back by the Company at their issue price and the proceeds applied to repay the Scheme Loan. Mr Holley will not benefit from any appreciation in the market price of the Company's shares in these circumstances.
