Appendix 3B and Notice in accordance with Section 708A(5)(e) of the Corporations Act

Intec Ltd (ASX code: INL) advises that on 22 December 2009 it received its second monthly drawdown of US\$250,000 under the Convertible Note issued to La Jolla Cove Investors, Inc. (see INL's ASX announcement on 17 November 2009). In accordance with the terms of the Convertible Note, INL has received instructions for a partial conversion in respect of which INL shares have been issued as set out in the attached Appendix 3B, following which there remains a principal cash amount of US\$369,733 outstanding.

Intec Ltd also advises it has received share applications for 8,666,666 fully paid INL shares at \$0.015 each from parties associated with Martin Place Securities Pty Ltd. These shares were issued as a result of a prior agreement entered into with Martin Place Securities Pty Ltd to underwrite (in part) an optional placement between Green Resources (Asia Pacific) Holding Limited and INL.

Secondary Trading Exemption

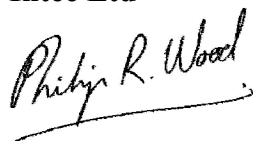

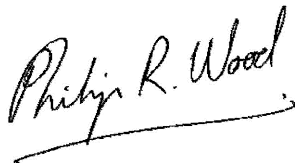
