SciDev Issue of SPP Shares and Appendix 2A

SciDev Limited (ASX:SDV; **SciDev**, or the **Company**) notes the close of its recent Share Purchase Plan (**SPP**) (ref: ASX 17 August 2020).

The SPP offer was heavily oversubscribed with over \$5 million in applications lodged. Final processing and reconciliation has taken place and the new SPP shares (and scale-back refunds) will both be issued today. SciDev thanks shareholders for their support.
