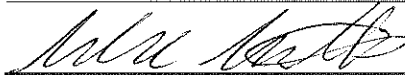

## DIRECTIONS

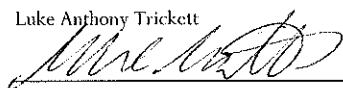
