REPORT ON QUARTERLY ACTIVITIES TO ACCOMPANY APPENDIX 4C

Q4 FY26 – Operations

Net cash from operating activities was negative in the fourth quarter totalling \$57,000 and negative \$368,000 for the financial year to 30 June 2026.

Cash on hand at 30 June 2026

The Company had funds / interest bearing deposits on hand totalling \$7.809m.

Payments to related parties of the entity and their associates

The amount disclosed in item 6.1 in the accompanying Appendix 4C relates to the payment of directors' fees.

Corporate activities

The Company refers to its most recent announcement dated 26 June 2026.

The Company is currently reviewing a small number of transaction opportunities that are in various stages of progress and will provide an update if any are likely to result in a transaction.

Suspension of Securities

As previously advised to the market, SIV Capital Limited securities were suspended from quotation on 18 December 2024. ASX had determined at that time that SIV's operations were not adequate to warrant continued quotation of its securities and therefore the Company was in breach of Listing Rule 12.1 and further noting that until ASX could be satisfied the Company was in compliance with the Listing Rules, in particular Listing Rules 12.1 and 12.3, would not reinstate SIV's securities to quotation.

In the meantime, the Company will continue to release periodic disclosure to ensure the market is fully informed under Listing Rule 3.1-3.1B.
