Extension of deadline for re-admission to the Official List and extension of Offers

Further to the Company's previous announcements on 19 November 2020 and 18 January 2021, and following ongoing discussions with the ASX, Sprintex Limited (ASX:SIX) (Company) is pleased to advise shareholders that the ASX has granted an extension of the deadline to meet re-listing conditions. The previously advised deadline of 22 February 2021 has now been extended until 31 March 2021.
