BUSINESS OF THE MEETING

FINANCIAL STATEMENTS AND REPORTS

To receive and consider the annual financial report of the Company for the financial year ended 30 June 2025 together with the declaration of the Directors, the Director's report, the Remuneration Report and the auditor's report.

1. RESOLUTION 1 – ADOPTION OF REMUNERATION REPORT

To consider and, if thought fit, to pass, with or without amendment, the following resolution as a **non-binding resolution**:

"That, for the purposes of section 250R(2) of the Corporations Act and for all other purposes, approval is given for the adoption of the Remuneration Report as contained in the Company's annual financial report for the financial year ended 30 June 2025."

Note: the vote on this Resolution is advisory only and does not bind the Directors or the Company.

2. RESOLUTION 2 – ELECTION OF LINCOLN LIU

To consider and, if thought fit, to pass, with or without amendment, the following resolution as an **ordinary resolution**:

"That, for the purpose of clause 6.3 of the Constitution, Listing Rule 14.4 and for all other purposes, Lincoln Liu, a Director who was appointed casually on 8 April 2025, retires, and being eligible, is elected as a Director."

Voting Prohibition Statements

In accordance with section 249L of the Corporations Act, Shareholders are advised that:

- each Shareholder has a right to appoint a proxy;
- the proxy need not be a Shareholder of the Company; and
- a Shareholder who is entitled to cast two or more votes may appoint two proxies and may specify the proportion or number of votes each proxy is appointed to exercise. If the Shareholder appoints two proxies and the appointment does not specify the proportion or number of the member's votes, then in accordance with section 249X(3) of the Corporations Act, each proxy may exercise one-half of the votes.

Shareholders and their proxies should be aware that:

- if proxy holders vote, they must cast all directed proxies as directed; and
- any directed proxies which are not voted will automatically default to the Chair, who must vote the proxies as directed.

EXPLANATORY STATEMENT

This Explanatory Statement has been prepared to provide information which the Directors believe to be material to Shareholders in deciding whether or not to pass the Resolutions.

1. FINANCIAL STATEMENTS AND REPORTS

In accordance with the Corporations Act, the business of the Meeting will include receipt and consideration of the annual financial report of the Company for the financial year ended 30 June 2025 together with the declaration of the Directors, the Directors' report, the Remuneration Report and the auditor's report.

The Company will not provide a hard copy of the Company's annual financial report to Shareholders unless specifically requested to do so. The Company's annual financial report is available on its website at www.sultanresources.com.au.

2. RESOLUTION 1 – ADOPTION OF REMUNERATION REPORT

2.1 General

The Corporations Act requires that at a listed company's annual general meeting, a resolution that the remuneration report to be adopted must be put to the shareholders. However, such a resolution is advisory only and does not bind the company or the directors of the company.

The remuneration report sets out the company's remuneration arrangements for the directors and senior management of the company. The remuneration report is part of the directors' report contained in the annual financial report of the company for a financial year.

The chair of the meeting must allow a reasonable opportunity for its shareholders to ask questions about or make comments on the remuneration report at the annual general meeting.

2.2 Voting consequences

A company is required to put to its shareholders a resolution proposing the calling of another meeting of shareholders to consider the appointment of directors of the company (**Spill Resolution**) if, at consecutive annual general meetings, at least 25% of the votes cast on a remuneration report resolution are voted against adoption of the remuneration report and at the first of those annual general meetings a Spill Resolution was not put to vote. If required, the Spill Resolution must be put to vote at the second of those annual general meetings.

If more than 50% of votes cast are in favour of the Spill Resolution, the company must convene a shareholder meeting (**Spill Meeting**) within 90 days of the second annual general meeting.

All of the directors of the company who were in office when the directors' report (as included in the company's annual financial report for the most recent financial year) was approved, other than the managing director of the company, will cease to hold office immediately before the end of the Spill Meeting but may stand for re-election at the Spill Meeting.

Following the Spill Meeting those persons whose election or re-election as directors of the company is approved will be the directors of the company.

2.3 Previous voting results

At the Company's previous annual general meeting the votes cast against the remuneration report considered at that annual general meeting were less than 25%. Accordingly, the Spill Resolution is not relevant for this Meeting.

3. RESOLUTION 2 – ELECTION OF LINCOLN LIU

3.1 General

The Constitution allows the Directors to appoint at any time a person to be a Director either to fill a casual vacancy or as an addition to the existing Directors, but only where the total number of Directors does not at any time exceed the maximum number specified by the Constitution.

Pursuant to the Constitution and Listing Rule 14.4, any Director so appointed holds office only until the next annual general meeting and is then eligible for election by Shareholders but shall not be taken into account in determining the Directors who are to retire by rotation (if any) at that meeting.

Lincoln Liu, having been appointed by other Directors on 8 April 2025 in accordance with the Constitution, will retire in accordance with the Constitution and Listing Rule 14.4 and being eligible, seeks election from Shareholders.

Further information in relation to Lincoln Liu is set out below.

Qualifications, experience and other material directorships	Mr Liu has acted in various roles as advisor to numerous mining companies across several commodities and particularly in their growth phase. He has worked in the Australian equities market for 15 years. His experience includes trading, equities research and investment banking having completed several IPO, capital raising, M&A, and private equity deals. He is the founder of a Sydney based corporate advisory firm servicing a range of growth companies in the mining and technology sectors
Term of office	Lincoln Liu has served as a Director since 8 April 2025.
Independence	If elected, the Board considers that Lincoln Liu will be an independent Director.
Other material information	The Company conducts appropriate checks on the background and experience of candidates before their appointment to the Board. These include checks as to a person's experience, educational qualifications, character, criminal record and bankruptcy history. The Company undertook such checks prior to the appointment of Lincoln Liu.
Board recommendation	Having received an acknowledgement from Lincoln Liu that they will have sufficient time to fulfil their responsibilities as a Director and having reviewed the performance of Lincoln Liu since their appointment to the Board and the skills, knowledge, experience and capabilities required by the Board, the Directors (other than Lincoln Liu) recommend that Shareholders vote in favour of this Resolution.

3.2 Technical information required by Listing Rule 14.1A

If this Resolution is passed, Lincoln Liu will be elected to the Board as non-executive Director.

If this Resolution is not passed, Lincoln Liu will not continue in their role as a non-executive Director. The Company may seek nominations or otherwise identify suitably qualified candidates to join the Company. As an additional consequence, this may detract from the Board and Company's ability to execute on its strategic vision.

4. RESOLUTION 3 – ELECTION OF MARK MITCHELL

4.1 General

The Constitution allows the Directors to appoint at any time a person to be a Director either to fill a casual vacancy or as an addition to the existing Directors, but only where the total number of Directors does not at any time exceed the maximum number specified by the Constitution.

Pursuant to the Constitution and Listing Rule 14.4, any Director so appointed holds office only until the next annual general meeting and is then eligible for election by Shareholders but shall not be taken into account in determining the Directors who are to retire by rotation (if any) at that meeting.

Mark Mitchell, having been appointed by other Directors on 8 April 2025 in accordance with the Constitution, will retire in accordance with the Constitution and Listing Rule 14.4 and being eligible, seeks election from Shareholders.

Further information in relation to Mark Mitchell is set out below.

Qualifications, experience and other material directorships	Mr Mitchell has been a geologist for over 35 years in exploration in rare metals, lithium and base metals in Australia and international jurisdictions. He has significant experience ranging from targeting through to resource evaluation and has been successful in the discovery of several mineral deposits in Australia. He has acted in the capacity of company liaison representative on various research projects with AMIRA, CET, GRC as well as a brief period on the CME Exploration committee. He has geological membership with the Geological Society of Australia and Australian Institute of Geoscientists and is a Registered Professional Geoscientist (No: 10049).
Term of office	Mark Mitchell has served as a Director since 8 April 2025.
Independence	If elected, the Board considers that Mark Mitchell will be an independent Director.
Other material information	The Company conducts appropriate checks on the background and experience of candidates before their appointment to the Board. These include checks as to a person's experience, educational qualifications, character, criminal record and bankruptcy history. The Company undertook such checks prior to the appointment of Mark Mitchell.
Board recommendation	Having received an acknowledgement from Mark Mitchell that they will have sufficient time to fulfil their responsibilities as a Director and having reviewed the performance of Mark Mitchell since their appointment to the Board and the skills, knowledge, experience and capabilities required by the Board, the Directors (other than Mark Mitchell) recommend that Shareholders vote in favour of this Resolution.

4.2 Technical information required by Listing Rule 14.1A

If this Resolution is passed, Mark Mitchell will be elected to the Board as a non-executive Director.

If this Resolution is not passed, Mark Mitchell will not continue in their role as a non-executive Director. The Company may seek nominations or otherwise identify suitably qualified candidates to join the Company. As an additional consequence, this may detract from the Board and Company's ability to execute on its strategic vision.

5. RESOLUTION 4 – APPROVAL OF 7.1A MANDATE

5.1 General

This Resolution seeks Shareholder approval by way of special resolution for the Company to have the additional 10% placement capacity provided for in Listing Rule 7.1A to issue Equity Securities without Shareholder approval.

Broadly speaking, and subject to a number of exceptions, Listing Rule 7.1 limits the amount of equity securities that a listed company can issue without the approval of its shareholders over any 12 month period to 15% of the fully paid ordinary shares it had on issue at the start of that period.

Under Listing Rule 7.1A, an Eligible Entity may seek shareholder approval by way of a special resolution passed at its annual general meeting to increase this 15% limit by an extra 10% to 25% (**7.1A Mandate**). An Eligible Entity means an entity which is not included in the S&P/ASX 300 Index and has a market capitalisation of \$300,000,000 or less. As of the date of this Notice, the Company's market capitalisation is \$1,827,584. The Company is therefore an Eligible Entity.

5.2 Technical information required by Listing Rule 14.1A

For this Resolution to be passed, at least 75% of votes cast by Shareholders present and eligible to vote at the Meeting must be cast in favour of the Resolution.

If this Resolution is passed, the Company will be able to issue Equity Securities up to the combined 25% limit in Listing Rules 7.1 and 7.1A without any further Shareholder approval.

If this Resolution is not passed, the Company will not be able to access the additional 10% capacity to issue Equity Securities without Shareholder approval under Listing Rule 7.1A and will remain subject to the 15% limit on issuing Equity Securities without Shareholder approval set out in Listing Rule 7.1.

6.1 Background

As announced on 17 September 2025 the Company has entered into a binding agreement with Aldoro Resources (**Acquisition Agreement**) to acquire interests in various mining tenements located in Western Australia and Namibia (**Tenements**).

The Tenements are being offered as a package with various complementary resource potentials representing an attractive business opportunity for the Company to add value to the Company.

The Company sees this as an opportunity to access prime locations that complement their gold focus with walk up ground access.

Pursuant to the Acquisition Agreement, in consideration for and on completion of the acquisition of the Tenements, the Company agreed to pay/issue to Aldoro Resources:

- (a) a cash sum of \$50,000;
- (b) 286,449,355 Shares, the subject of Resolution 5; and
- (c) an aggregate of \$1,500,000, being:
 - (i) \$750,000 to be paid upon achievement of a Mineral Resource Estimate as defined in the JORC Code (2012 Edition) of at least 25 million tonnes at an average grade equal to or greater than 0.8% Ni from the Tenements, classified as 'Inferred', within 36 months following completion; and
 - (ii) \$750,000 to be paid upon satisfaction of the Company making a decision to mine in respect to any of the Tenements within 36 months of completion.

The Acquisition Agreement otherwise contains standard provisions for an agreement of its nature.

For further details in respect to the Tenements being acquired refer to the Company's announcement dated 17 September 2025.

6.2 General

This Resolution seeks Shareholder approval for the purposes of Listing Rule 7.1 for the issue of 286,449,355 Shares to Aldoro Resources (or its nominees).

A summary of Listing Rule 7.1 is set out in Section 5.1.

attaching quoted Option for every two Shares subscribed for an issued, exercisable at \$0.03 on or before 12 March 2027 (**SLZO Options**) (**Placement**).

The Placement comprises:

- (a) an aggregate of 73,380,679 Shares which were issued to unrelated professional and sophisticated investors (**Placement Participants**) on 21 October 2025 pursuant to the Company's placement capacity under Listing Rule 7.1 and 7.1A, ratification of which is sought under Resolutions 7 and 8; and
- (b) subject to Shareholder approval, up to a further 48,841,543 Shares to be issued to the Placement Participants (or their nominees) (being the subject of Resolution 9); and
- (c) up to 61,111,111 SLZO Options which will be issued to Placement Participants on a one-for-two basis, subject to Shareholder approval under Resolution 10.

8.2 Use of funds

The proceeds from the Placement will be applied towards funding the strategic expansion of the Company's exploration portfolio, the commencement of exploration work on the Damara Gold Project and to support the Company's next phase of growth and transformation, enabling it to assess and pursue further potential acquisitions in the gold and critical metals sector.

8.3 Lead Manager

The Company engaged Xcel Capital Pty Ltd (**Xcel Capital**) to act as lead manager to the Placement. A summary of the key terms and conditions of the mandate with Xcel Capital (**Lead Manager Mandate**) is set out below:

TERM	The Lead Manager Mandate commenced on 9 October 2025 and will continue for a period of eighteen (18) months.
CONSIDERATION	In consideration for its services, the Company agreed to pay/issue Xcel Capital: (a) Lead Manager Fee: a lead manager fee of \$20,000 (plus GST) on completion of the Placement; (b) Placement fee: a placement fee of 6% (exclusive of GST) of the gross funds raised by Xcel Capital under the Placement; and (c) Lead Manager Options: 30,000,000 SLZO Options, subject to Shareholder approval.
REIMBURSEMENT OF EXPENSES	The Company agreed to reimburse Xcel Capital for all reasonable out-of-pocket expenses incurred in its role as lead manager, subject to a limit of \$5,000. Any expense greater than this limit requires the prior written consent of the Company.

The Lead Manager Mandate otherwise contains terms and conditions standard for an agreement of this nature.

The Company is seeking Shareholder approval for the issue of SLZO Options payable under the Lead Manager Mandate to Xcel Capital pursuant to Resolution 11.

9. RESOLUTIONS 7 AND 8 – RATIFICATION OF PRIOR ISSUE OF SHARES TO PLACEMENT PARTICIPANTS

9.1 General

As set out in Section 8.1, these Resolutions seek Shareholder ratification for the purposes of Listing Rule 7.4 for the issue of an aggregate of 73,380,679 Shares to those Placement Participants, at an issue price of \$0.009 per Share to raise \$660,426.

On 21 October 2025, 50,233,688 Shares were issued pursuant to the Company's capacity under Listing Rule 7.1 (being, the subject of Resolution 7) and 23,146,991 Shares were

issued pursuant to the Company's placement capacity under Listing Rule 7.1A (the subject of Resolution 8).

9.2 Listing Rules 7.1 and 7.1A

A summary of Listing Rule 7.1 is set out in Section 5.1 above.

Under Listing Rule 7.1A however, an Eligible Entity can seek approval from its members, by way of a special resolution passed at its annual general meeting, to increase this 15% limit by an extra 10% to 25%. The Company obtained this approval at its annual general meeting held on 21 November 2024. The Company's ability to utilise the additional 10% capacity is conditional on Resolution 4 being passed at this Meeting.

The issue does not fit within any of the exceptions set out in Listing Rule 7.2 and, as it has not yet been approved by Shareholders, it effectively uses up part of the 25% limit in Listing Rules 7.1 and 7.1A, reducing the Company's capacity to issue further equity securities without Shareholder approval under Listing Rule 7.1 and 7.1A for the 12 month period following the date of the issue.
