Cleansing Notice under section 708A(5)(e) of the Corporations Act

This notice is given by SenSen Networks Ltd (ASX : SNS) (**SenSen** or **Company**) under section 708A(5)(e) of the *Corporations Act 2001* (Cth) (**Corporations Act**).

SenSen has today issued 1,103,003 fully paid ordinary shares (**Shares**) in the capital of the Company, under the SenSen Salary Sacrifice Plan, as announced in the Quarterly Activities and Cashflow Report March 2023.

Under the Salary Sacrifice Plan, senior staff members will receive ordinary shares in SenSen in lieu of that component of their salary calculated on a 20-day volume weighted average price. It is anticipated that such Shares will be issued monthly, but always subject to the SenSen Securities Trading Policy.

SenSen also refers to the Company's Appendix 2A lodged yesterday.

The Shares were issued to senior staff members other than Directors and will be issued within the ASX Listing Rule 7.1 15% placement capacity.
