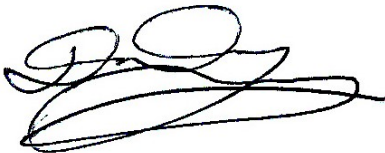
Proposed Issue of Securities – Employee Options
