### Synertec secures major SCADA upgrade contract with AGL

**Melbourne, Australia:** Technology design, development and engineering growth company, Synertec Corporation Limited (ASX: SOP, "Synertec" or "the Company") is pleased to provide further detail in relation to its 19<sup>th</sup> May 2026 announcement "Synertec Executes Letter of Intent for Major Energy Project".

#### Highlights

- Follows Synertec's ASX announcement of 19 May 2026 regarding a Letter of Intent with a major Australian energy operator, whose identity was withheld
- AGL has now executed a contract under the parties' existing Framework Agreement with Synertec to deliver the SOLIS Project, a major Supervisory Control and Data Acquisition (SCADA) upgrade across AGL's national gas and renewables operations
- Scope includes implementation across 26 sites across Australia, with centralised control functionality located in Melbourne
- Phase 1 delivery is valued at approximately \$4million
- Reinforces Synertec's deliberate strategy and strengthening position as a leading provider of advanced SCADA and automation systems for critical infrastructure

**Melbourne, Australia:** Technology design and development growth company, Synertec Corporation Limited (ASX: SOP, "Synertec", "the Company" or "the Group") is pleased to announce it has executed a contract with AGL Energy Limited ("AGL") to deliver AGL's SOLIS Project, a major upgrade of its national SCADA infrastructure supporting its gas and renewable energy operations.

This contract follows the Company's ASX announcement dated 19 May 2026 regarding the execution of a Letter of Intent ("LOI") with a major Australian energy operator. With the signing of the binding contract, Synertec can now confirm that the customer referred to in that announcement was AGL.

The contract has been executed under the Framework Agreement entered into between Synertec and AGL in October 2025 and formalises the project scope and commercial arrangements contemplated under the LOI.

The SOLIS Project will replace AGL's legacy SCADA system with a modern, cyber-secure and scalable platform across an initial 25 operational sites. The upgraded system will centralise monitoring and control within AGL's Melbourne-based operations centre, providing a "single pane of glass" view across AGL's national gas and renewable energy asset portfolio.

Phase 1 delivery is valued at approximately \$4.0 million, with project activities already underway following commencement of approved early works under the LOI.

This project further demonstrates that Synertec's considered and deliberate strategy to target complex, large-scale and distributed SCADA and automation projects is delivering significant and sustainable value for our shareholders. Similar project wins include Metro Trains Melbourne, Melbourne Water, and the Australian Nuclear Scientific Organisation. The SOLIS Project further reinforces Synertec as a leading provider of advanced digital technology solutions to Australian critical infrastructure for the benefit of the Australian public.

Additionally, this award demonstrates Synertec's ability to compete against national and international competitors to secure high-value, strategically important technology projects for tier-one Australian clients. It reflects the Company's ongoing commitment to supporting the digital transformation of critical infrastructure through advanced, reliable, and technically
