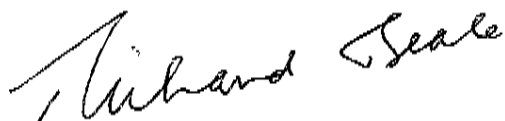

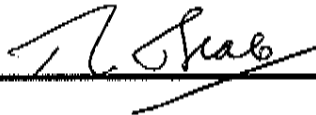

DIRECTIONS
