CHAIRMAN AND MANAGING DIRECTOR'S REVIEW

Dear Fellow Shareholders

Welcome to this year's Annual Report. The past year has seen significant activity by your Company, which has enhanced the value of our emerging portfolio of copper, gold and critical minerals.

Importantly, our focused approach ensures Superior has strong foundations to benefit from record high gold prices, strong copper prices and an anticipated general market upturn for the small cap resources sector.

Significantly too, thanks to our shareholders Superior has been able to secure sufficient capital to pursue our value-enhancing exploration activities. Rising inflation and interest rates together with geopolitical tensions have made investors increasingly risk-averse, making shareholder support more valuable than ever.

Looking back at the past year, there has been major progress at Superior's wholly owned Greenvale Project, with the Bottletree Copper-Gold Prospect and Steam Engine Gold Deposit the focus of the Company's exploration efforts, together with the Cockie Creek Porphyry Prospect.

Steaming ahead

The gold price has hit record highs in 2024 and with analysts expecting further price gains next year, Superior's Steam Engine Gold Project has become an increasingly valuable project.

In June 2024, Superior announced plans for a revision of the 2021 Scoping Study, resource expansion and exploration drilling programs to accelerate resource growth. Considering the 2021 study was conducted with a base case Australian dollar gold price of \$2,200 per ounce compared to current levels approaching \$4,000, and in view of an upgraded Mineral Resource estimate, this was considered offering enormous upside for Superior.

Post-balance date, in July 2024 Superior commenced drilling at Steam Engine with the aim of accelerating expansion of the resource; maximise pit optimisation and generate a maiden Ore Reserve; extend the strike lengths of the Steam Engine and Eastern Ridge Lodes; and test multiple new high-grade lode targets.

Following these activities, in September 2024 Superior announced a revised Scoping Study for Steam Engine, which confirmed the opportunity to develop a low capex, open pit mining and toll treatment operation or a standalone on-site processing plant operation.

The study showed Steam Engine could become a highly valuable operation for the Company, with an estimated pre-tax Net Present Value (NPV) of around \$38

million for a toll treatment operation or \$42 million for standalone processing. Further upside potential was identified from Mineral Resource extensions along strike from existing lode systems and from new lode targets, including a potential southern extension to the Steam Engine Lode.

Superior subsequently announced the discovery of stacked, multiple lode, high grade zones at the Steam Engine and Eastern Ridge lodes, with grades of up to 7.18 grams per tonne (g/t) gold. These zones have potential to develop into significant high grade gold shoots with further drilling. Drilling at the Eastern Ridge Lode has been limited compared to the Steam Engine Lode, highlighting the potential for further resource expansions during Phase 2 of the Greenvale drilling program, which commenced in October 2024.

Copper gains

Like gold, the copper price has also hit new highs in 2024 amid constrained supply and increasing demand for the red metal, which is seen as essential to the global energy transition.

In this climate, Superior's copper projects have become increasingly strategic assets with potential for considerable value uplift.

In October 2023, Superior announced the start of a Phase 2 drilling program at Bottletree, comprising 10 diamond core holes for a total of 4,250m. The

program targeted an interpreted intrusion centre of the large-scale copper-gold-molybdenum porphyry system discovered during 2022, together with strike extensions to the wall rock porphyry zone associated with the Discovery Outcrop.

In April 2024, Superior was awarded a \$300,000 Collaboration Exploration Initiative (CEI) grant by the Queensland Government for the drilling of two critical diamond holes at Bottletree. The CEI grant was a competitive process, validating Bottletree's value and the significance of the Greenvale Terrane, being an important and previously unrecognised copper-gold porphyry belt.

In just three years of exploration, Superior has confirmed the existence of two large porphyry copper-gold-molybdenum systems and several other likely porphyry systems.

Superior subsequently announced new drilling results from Bottletree, with the results supporting earlier modelling indicating that a porphyry potassic core is likely located several hundred metres south-west of the Discovery Outcrop.

Post-balance date, in August 2024 Superior announced more exciting results from Bottletree, with a high-resolution gravity survey showing a significant gravity anomaly around 400m south of previous drilling programs. This potentially represents the core of the

Bottletree porphyry copper-gold system, giving Superior more promising targets to pursue in upcoming drilling.

Another exciting copper prospect in the Greenvale Project is Cockie Creek, where Superior launched a maiden diamond drilling program in August 2023. Cockie Creek is a porphyry copper-gold-molybdenum system with an historical pre-JORC 2012 Mineral Resource, however it has been subject to very limited historical exploration.

In September 2023, Superior announced the first assays from the maiden drilling program, which showed strong, high grade porphyry copper mineralisation. Results from the second hole, announced a month later, were also of relatively high grade in terms of porphyry copper-gold-molybdenum deposits, confirming the grades encountered in nearby historical drill holes.

The third hole, announced in November 2023, showed a much broader width of higher grade porphyry copper and gold mineralisation at deeper levels around 400m west of the second drill hole. Results from the fourth, fifth and sixth holes announced in December 2023 continued to exceed expectations, reinforcing the potential for a large system.

Amid such promising results, it is important to recognise the main contributors to our success, being our staff, Directors, contractors, shareholders and everyone associated with the Company. In this regard, the recent oversubscribed Rights Issue in difficult market conditions to fund a feasibility study and drilling at Steam Engine and Greenvale demonstrates the confidence of investors in the Company's strategy.

With a strong pipeline of projects in gold, copper and critical minerals, Superior is well placed to increase shareholder value. As the world economy recovers in 2024-25 and demand for these key commodities continues to rise, your Company is set to benefit and we look forward to delivering on this potential in the year ahead.

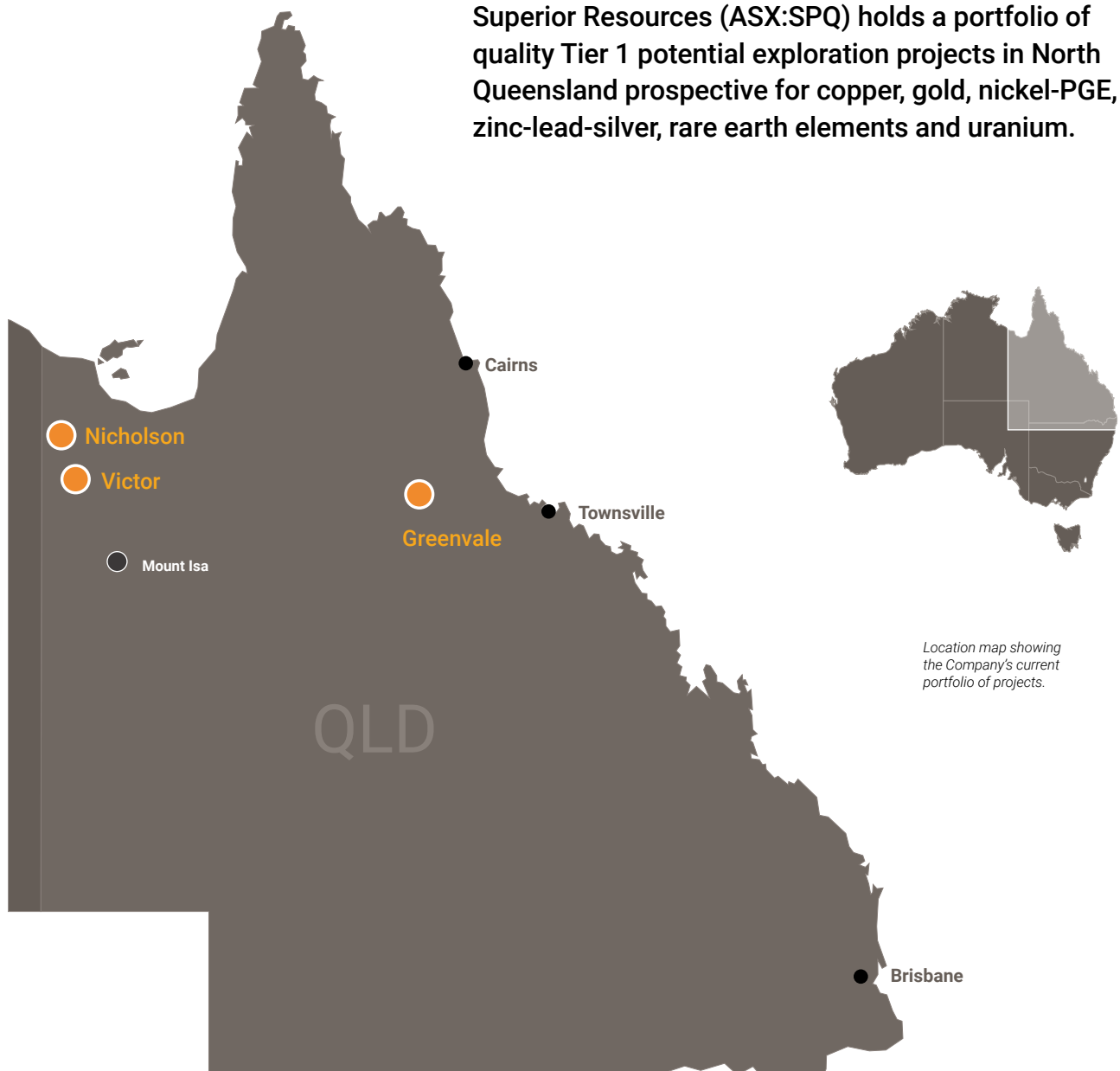

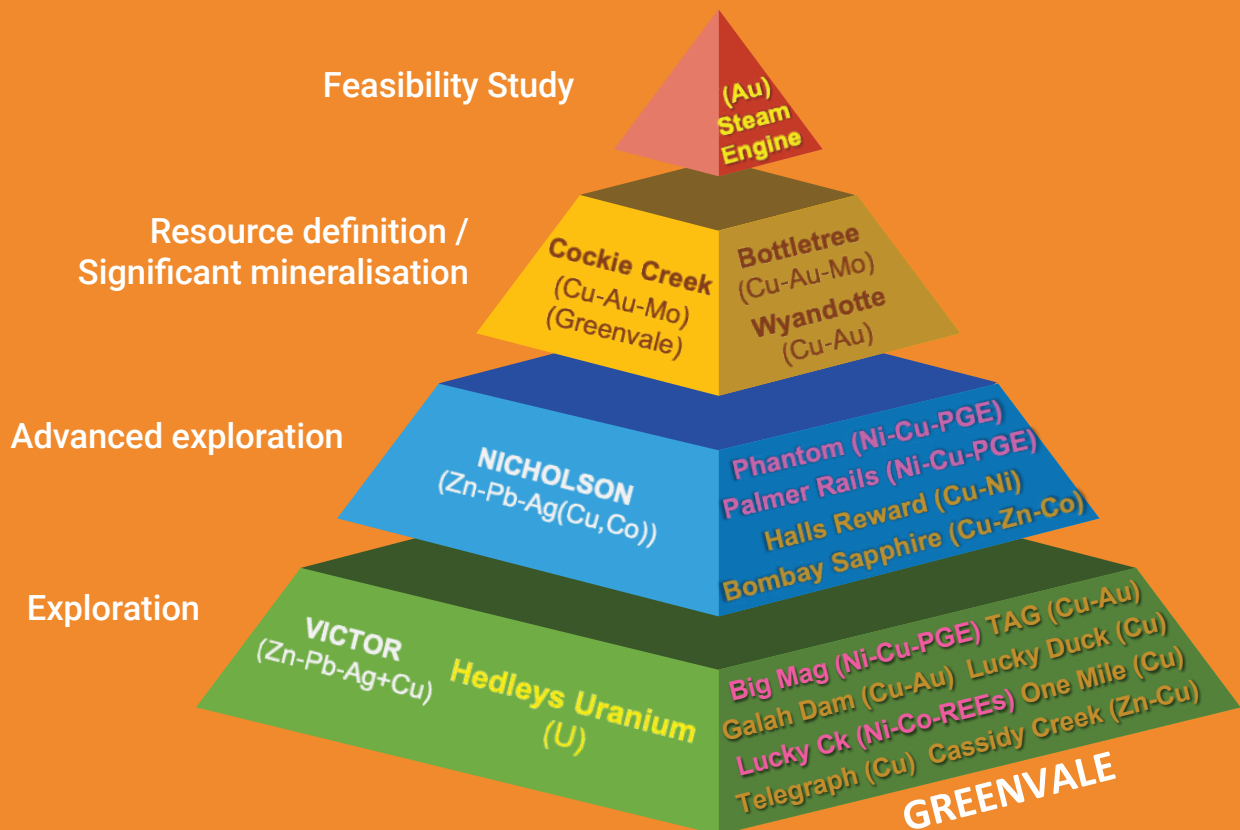
Review of Operations

Superior Resources (ASX:SPQ) holds a portfolio of quality Tier 1 potential exploration projects in North Queensland prospective for copper, gold, nickel-PGE, zinc-lead-silver, rare earth elements and uranium.



LEVERAGING THE GREEN TRANSITION

Superior's projects are leveraging the green transition, with our portfolio of key forward-facing metals including copper, nickel, PGEs, cobalt and zinc, together with uranium and rare earth elements.



Superior Resources Limited (ASX:SPQ) is dedicated to exploring its portfolio of highly promising projects situated in top-tier mining jurisdictions across Queensland.

The Company's 100% owned Greenvale Project was the primary focus of activities for Superior during the period. Greenvale has potential to host diverse mineral deposits, including porphyry copper-gold, orogenic gold, VMS copper, and Voisey's Bay-style magmatic nickel-copper-PGE sulphides.

With around 60 high-potential prospects, the region presents a promising opportunity for substantial resource discoveries across multiple valuable mineral types. Superior is taking the lead with Tier-1 potential copper-gold porphyry exploration in this part of Australia.

Covering an area of 2,307 sq km, the Greenvale Project is in a notable economically significant area, proximal to the Kidston, Balcooma, Surveyor, Dry River South and Greenvale Nickel Mine deposits.



The nearby Kidston Clean Energy Hub, currently under construction at the former Kidston Mine site, will supply 100% renewable energy into the National Energy Market electricity system via a transmission line that passes through the centre of the Greenvale Project area.

The Company's activities during the period were concentrated on the Cockie Creek, Bottletree and Steam Engine prospects, all within the Greenvale Project area. Strong investor support for these exploration programs was evidenced by the \$2,000,000

placement completed in December 2023. Additionally, in April 2024, the Queensland Government validated the significance of the Bottletree porphyry system by awarding a \$300,000 Collaborative Exploration Initiative (CEI) grant for drilling at the prospect.

Cockie Creek

Of Superior's porphyry prospects, Cockie Creek is the most advanced, on the basis of an historical Mineral Resource being established on what the Company refers to as the "Discovery Outcrop". Based on the principle of a need to accelerate the testing of its many porphyry prospects, the Company advanced Cockie Creek with a maiden drilling program to establish a JORC 2012 compliant Mineral Resource Estimate and to expand the size of the resource. The drilling program at Cockie Creek is the first systematic drilling on site for over 30 years and is the first to target the prospect as a porphyry system.

Cockie Creek is a porphyry copper-gold-molybdenum system. The mineralisation at Cockie Creek extends over 1.2 km with a true width of up to 60 metres. Previous drilling has only been to shallow depths. The intrusive complex within which the historic Mineral Resource is located, is interpreted to be approximately 3.5kms by 2.5kms in size, based on aerial magnetic data. A JORC (2004) compliant Mineral

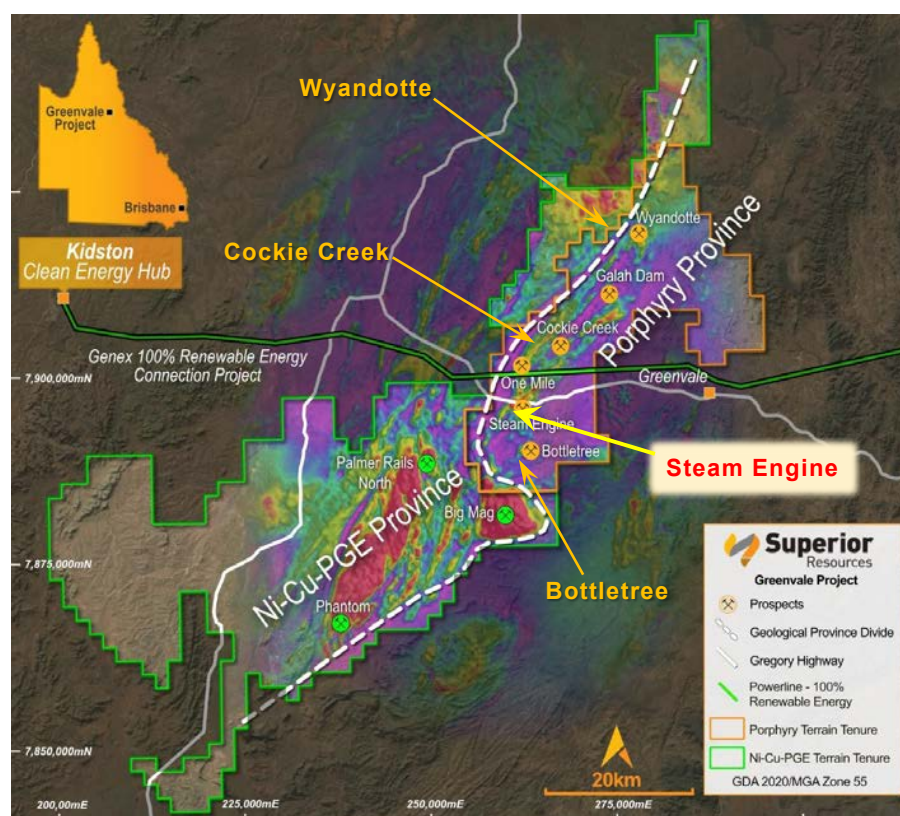


Figure 1. Regional aerial magnetics over the Greenvale Project area showing the newly recognised porphyry province (tenements outlined in amber) and the magmatic Ni-Cu-PGE sulphide province (tenements outlined in green).

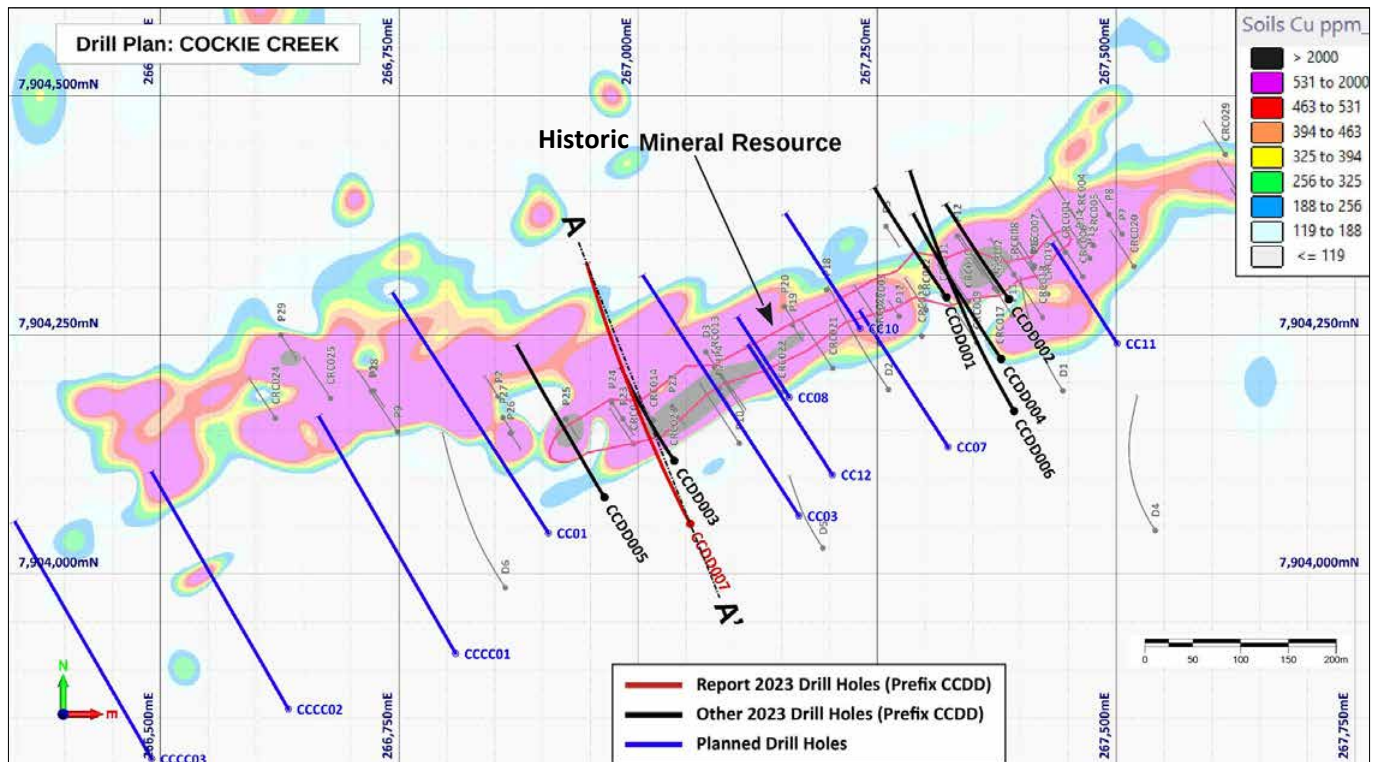


Figure 2. Plan map of the Cookie Creek Discovery Outcrop area showing completed drill holes CCDD001 – CCDD007 (in black).

Resource is located near the eastern end of the intrusive complex. Directly beneath the mineralisation lies a strong IP chargeability anomaly that has not been adequately drilled. Modelling by the Company indicates that a second chargeability anomaly lies north of and parallel to the main anomaly. The northern anomaly has not historically been drilled.

The as-planned drilling program comprises 17 HQ diamond core holes for a total of 6,650m to:

- target two high order induced polarisation (IP) chargeability anomalies directly below the Discovery Outcrop. The chargeability anomalies are interpreted to represent the upper zones of a mineralised Cu-Au-Mo porphyry core;
- target interpreted large intrusion centres west of the Discovery Outcrop; and
- establish a JORC (2012) compliant upgraded Mineral Resource Estimate on the Discovery Outcrop

By October 2023, Superior had completed seven holes for a total of 2,773m of core.

The early results from the drilling program confirmed a greater extent of copper mineralisation than historically reported.

The initial holes drilled intersected a range of porphyritic intrusive rocks, which include quartz diorites, diorites and tonalites that appear to have intruded several metavolcanic units.

The most interesting unit, close to surface, is a medium to coarse grained textured quartz diorite that has been subjected to biotite and K-feldspar alteration that is typical of porphyry-style alteration in the potassic zone.

Copper mineralisation observed in CCDD001, CCDD002 and CCDD003 correlates well with biotite and K-feldspar alteration within the porphyritic quartz diorite, tonalite and diorite.

The mineralisation is predominantly disseminated and focussed along strong foliation structures, although some mineralisation appears to be remobilised out of quartz vein structures that are possible typical porphyry B-veins.

The visually observed mineralisation within the core is generally present over wider intervals than historically reported. Due to the disseminated and foliated nature of the mineralisation, visual abundances are currently difficult to estimate.

Significantly, a previously unknown zone of bornite-magnetite-biotite mineralisation was intersected in CCDD001 from 245m to 254.2m (end of hole depth). This zone of bornite mineralisation is located outside the historically known copper mineralisation and outside the historical Mineral Resource envelope. Further drilling in September 2023 also confirmed that the strong visually observed copper sulphide mineralisation continued to be intersected for significant distances outside the historical Mineral Resource area. The holes also extended the mineralised zone down dip.

During the period assay results returned strong copper mineralisation.

Results included:

- 117m @ 0.52% Cu, 0.11g/t Au and 109ppm Mo from 20m (CCDD002) (refer to ASX announcement dated 16 October 2023)
- 71m @ 0.48% Cu and 70ppm Mo from 16m (CCDD001) (refer to ASX announcement dated 25 September 2023)
- 120m @ 0.45% Cu, 0.09g/t Au and 126ppm Mo from 92m (CCDD004) (refer to ASX announcement dated 11 December 2023)

- 108m @ 0.40% Cu, 0.09g/t Au and 104ppm Mo from 204m (CCDD006) (refer to ASX announcement dated 11 December 2023)
- 320m @ 0.21% Cu, 0.05 g/t Au and 31 ppm Mo from 176m (CCDD007) (refer to ASX announcement dated 29 January 2024)

The assays for CCDD005 (western zone) are slightly lower than those in CCDD004 and CCDD006 but still define an interval of significant Cu and Au mineralisation consistent with those encountered in the first (CCDD001) and second (CCDD002) drill holes of the program.

The broad interval of porphyry copper and gold mineralisation in CCDD007 in the western zone of Cookie Creek is approximately three times the length of the mineralised intervals in CCDD001, CCDD002, CCDD004 and CCDD006 in the eastern zone, although it has an overall lower average grade.

Importantly, the assays continue to confirm that the actual copper grades have consistently exceeded visual estimations of chalcopyrite mineralisation observed within the core.

The drilling program is currently paused to facilitate an interim period for data analysis and to optimise the specifications and positioning for the remaining deeper holes.

Bottletree

The Bottletree Prospect has been confirmed as a large porphyry copper-gold-molybdenum system by porphyry geological experts. The discovery of such a system in this location is significant as metallurgically-fertile likely-Orodocian-age porphyries similar to those of NSW were not previously known to exist in Queensland.

The Project is located around 210 km west of Townsville and only 5 km south of Superior's Steam Engine Gold Project.

Phase 1 drilling in 2022 comprising six diamond core holes (BTDD005-BTDD010) for 4,952 metres resulted in the discovery of a large (>1km diameter) porphyry-style alteration and copper-gold-molybdenum mineralisation system. At least two zones of wall rock-hosted porphyry style vein copper and molybdenite mineralisation (Wall Rock Porphyry Zone) were identified.

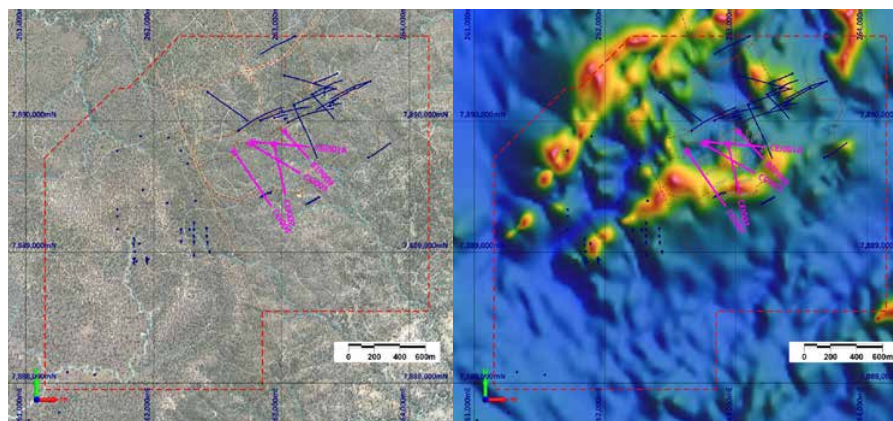


Figure 3. Satellite imagery (left) and TDr Vi NSSF-processed aerial magnetic imagery (right) of the Bottletree Prospect. Also shown are 2022 and 2023 drill program holes (blue trace) and the next stage porphyry core drill program holes (pink trace), which include planned CEI drill holes

Figure 4. The 3D inversion modelling on the Bottletree gravity data has defined two distinct gravity-high features

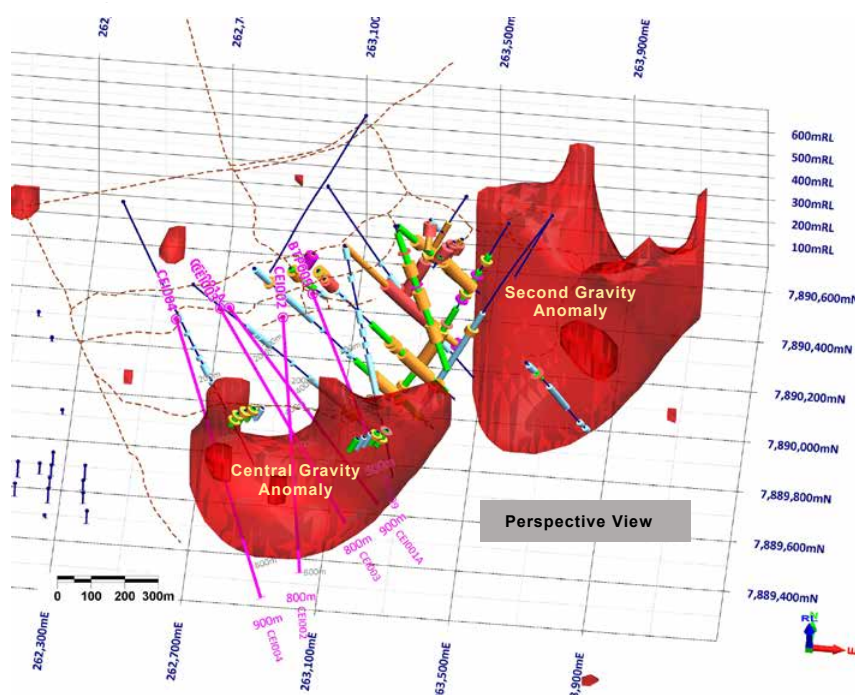
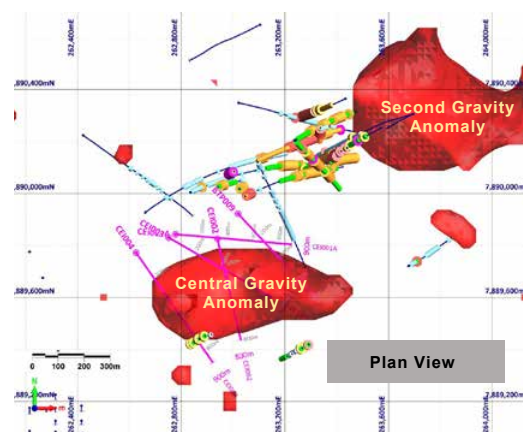


Figure 5. 3D inversion density model of the high resolution Bottletree ground gravity survey showing the central gravity anomaly and the northeastern gravity anomaly as high-density 2.8t/m³ iso-surfaces, viewed obliquely (above) and plan view (vertical-down) (right). 2022 and 2023 drill holes shown in blue trace together with down-hole assay grade categories. Planned holes to test the central anomaly (including CEI-funded holes) shown in pink trace.

The 2023 Phase 2 Bottletree drilling program included holes designed to test the size potential of the northeastern Wall Rock Porphyry Zone associated with the Discovery Outcrop as well as the nature of mineralisation at the southern Wall Rock Porphyry Zone.

A program of ten holes were planned to be drilled throughout 2023 and 2024 for a total of 4,250 metres however the onset of the northern monsoon season meant only three holes were completed during the field season.

Results from the three 2023 drill holes confirmed the continuity of mineralisation in the wall rocks at the Discovery Outcrop zone.

Drill holes BTDD011 and BTDD012 intersected broad widths of lower grade porphyry Cu-Au mineralisation associated with the Discovery Outcrop zone in the northeastern part of the Bottletree prospect. These results confirm that gaps between drill holes are mineralised and there is good continuity of mineralisation in that zone.

BTDD013 targeted an area several hundred metres further southwest than previous drilling and intersected hundreds of metres of low-grade Cu-Au mineralisation associated with weak to moderate biotite (potassic) and actinolite (calcic) alteration in meta-andesite and minor intrusions.

Results from BTDD013 support earlier modelling indicating that a high-priority porphyry core target is likely to be located several hundred metres to the southwest of the Discovery Outcrop. This was further substantiated by results from a high-resolution gravity survey announced in August 2024 which highlighted a large prominent gravity anomaly in that same area.

In April 2024 Superior was awarded a \$300,000 CEI Critical Minerals grant which will be applied directly to drilling two deep diamond drill holes to test these targets which are located approximately 400 metres to the southwest of all prior drilling conducted between 2021 to 2023. Drilling is expected to commence later in 2024.

Steam Engine Gold Project

The Steam Engine Gold Project (SEGP) is a unique gold deposit located between several actively explored high-potential porphyry Cu-Au-Mo prospects and a magmatic sulphide Ni-Cu-PGE province within the Company's Greenvale Project. It presents the Company with an opportunity to generate revenue in the short to medium term together with considerable upside potential to grow the Resource base into a substantial deposit.

The SEGP contains at least two sub-parallel gold-bearing lodes, referred to as the Steam Engine Lode and the Eastern Ridge lode. These have only been drilled to shallow levels with average vertical depths of 90 metres at the Steam Engine Lode and 35 metres at the Eastern Ridge Lode.

A Mineral Resource Estimate with a significant portion in the JORC 2012 Measured confidence category was established on the two lodes in 2022 (refer to the Mineral Resources Statement on page 63 for specific JORC (2012) confidence category information).

Lower Grade, Owner-Operated Processing Plant Model (lower cut-off grade of 0.25 g/t Au)

- 4.18 Mt @ 1.5 g/t Au for 196,000 oz Au

High Grade, Toll Treatment Model (higher cut-off grade of 1.0 g/t Au)

- 2.72 Mt @ 2.0 g/t Au for 171,000 oz Au

Post reporting period, on 4 July 2024, the Company announced that resource expansion and exploration drill programs to progress the SEGP towards development had commenced.

Note: Information in this report relating to Mineral Resource Estimates (MRE) and associated block models is a summary of information contained in the original ASX announcement "Material upgrade in Steam Engine Resource to 196,000 oz Au with 80.6% increase to Measured and Indicated categories," dated 11 April 2022. The Company is not aware of any new information that materially affects the MRE as presented and all material assumptions and economic parameters underpinning the estimates in the original market announcement continue to apply and have not materially changed.

The program aims to:

- accelerate expansion of the current 196,000oz Au Mineral Resource;
- maximise pit optimisation and generate a maiden Ore Reserve;
- extend strike lengths of Steam Engine and Eastern Ridge Lodes; and
- test multiple newly identified potentially high-grade lode targets

A total of 45 reverse-circulation (RC) drill holes totalling approximately 4,500 metres across the Steam Engine and Eastern Ridge lodes were planned with the objective to significantly expand the SEGP Mineral Resource. Drilling is estimated to complete in the second half of 2024.

The forward exploration program at the SEGP is also focussed on the identification of new lode zones

that have the potential to contribute significant resources to an open-cut mining operation. The program comprises initial soil geochemistry sampling programs and follow up slimline RC drilling programs.

Due to notable changes in the price and cost assumptions underlying its financial models, the Company revised its 2021 SEGP Scoping Study. The revised Scoping Study was completed in the second half of 2024 and reported to the market on 16 September 2024.

Wyandotte Prospect

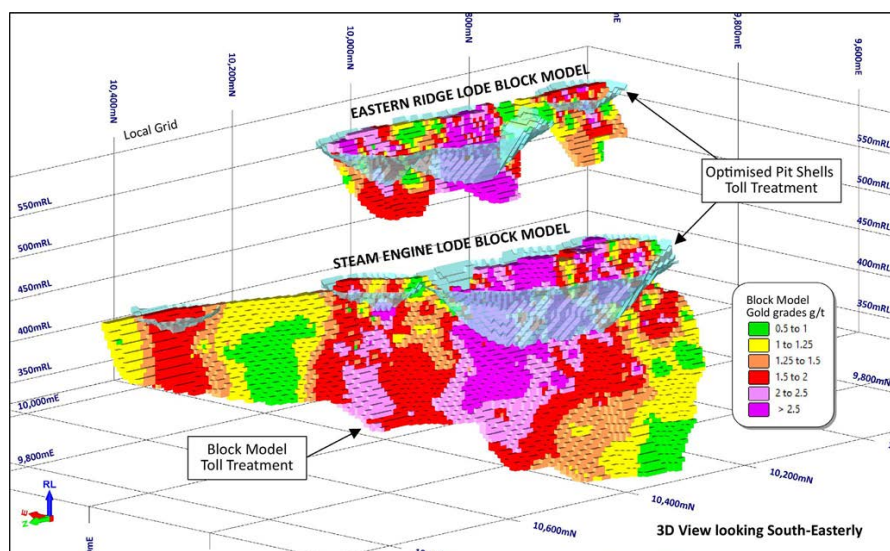
The Wyandotte Prospect is a shallow zone of high-grade copper mineralisation, which is potentially associated with a deeper intrusion related or porphyry system.

In June 2023, Superior announced plans for the first drilling at Wyandotte since 1975, with the drilling campaign scheduled for late 2023 – early 2024. Initial field work significantly upgraded its porphyry potential and scale however the Company suspended further work on this prospect while it directed its focus on the drill programs at the Cookie Creek, Bottletree and Steam Engine prospects.

Victor and Nicholson Projects

The Victor and Nicholson projects lie in the Carpentaria Zinc Province which contains 20% off the world's zinc resource inventory. Located north-west of Mount Isa, the projects provide potential for similar Mount Isa style zinc-lead-copper deposits with a portfolio of drill-ready targets.

No activities were undertaken at either of the Projects during the period while the Company's activities were focussed on the Greenvale Project area.

PRINCIPAL ACTIVITIES

During the year the principal activity of the Group was the continued evaluation and expansion of the Steam Engine Gold Deposit. The Group also continued exploration for copper-gold and magmatic nickel sulphide deposits in northern Queensland, Australia. There were no significant changes in the nature of the Company's activities during the year and no significant changes in activity are anticipated.

DIVIDENDS

There were no dividends paid to members during the financial year (2023: \$nil).

REVIEW OF OPERATIONS

The loss after tax for the year was \$1,408,348 (2023: loss of \$889,011).

30 June 2024 Operations Summary

The principal activity of the Group during the full year period was exploration for porphyry copper-gold, gold and nickel-copper-PGE deposits in northern Queensland, Australia. There were no significant changes in the nature of the Group's activities during the reporting period.

(a) COCKIE CREEK PORPHYRY COPPER PROSPECT (Greenvale)

A maiden drilling program at the Cockie Creek Porphyry Prospect commenced during July 2023 and represents the first significant program in more than 30 years and the first to specifically target a porphyry system.

Highly positive results have been returned from each of the holes, including confirmation that:

1. Cockie Creek is a porphyry Cu-Au-Mo system that is potentially of Ordovician age, similar to the Macquarie Arc deposits in NSW;
2. Cu mineralisation is developed over a significantly greater area than historically understood; and
3. the porphyry Cu mineralisation is of relatively high grade in porphyry deposit terms with the first two holes returning:
 - **71m @ 0.48% Cu and 70ppm Mo** from 16m (CCDD001)¹
incl. **31m @ 0.65% Cu and 80ppm Mo** from 36m; and
 - **117m @ 0.52% Cu, 0.11g/t Au and 109ppm Mo** from 20m (CCDD002)²
incl. **71m @ 0.69% Cu, 0.13g/t Au and 158ppm Mo** from 27m
incl. **36m @ 0.77% Cu, 0.14g/t Au and 146ppm Mo** from 56m
incl. **10m @ 1.08% Cu, 0.20g/t Au and 44ppm Mo** from 56m

Current Mineral Resource Estimate: **13MT @ 0.42% Cu (0.25% Cu cutoff grade) (JORC 2004)**³, based on strike length of 1.2kms and a maximum depth of 250m.

Two large, intense IP chargeability targets at depth beneath the defined structurally controlled mineralisation corridor, remain to be investigated by drilling.

(b) BOTTLETREE PORPHYRY COPPER PROSPECT (Greenvale)

The 2023 drilling program, targeting porphyry core(s) and delineating copper mineralisation within two Wall Rock Porphyry Zones was completed during December 2023.

Due to seasonal field constraints, only holes targeting the main Wall Rock Porphyry Zone were completed.

Results from BTDD011, BTDD012 and BTDD013 drilled during the 2023 drilling program, were reported on during the Quarter.

3D geological and mineralisation modelling.

Conducting 3D inversion modelling of high-resolution ground gravity survey data.

The Company was awarded a \$300,000 Collaborative Exploration Initiative (CEI) critical minerals grant for the drilling of two deep holes targeting a modelled porphyry core during the 2024 field season.

(c) STEAM ENGINE GOLD PROJECT (Greenvale)

A large 2024 Resource expansion and exploration drilling program was commenced at the Steam Engine Gold Project on 4 July 2024. The program objectives are to:

1. accelerate expansion of the current 196,000oz Au Mineral Resource;
2. generate a maiden Ore Reserve; and
3. test multiple newly identified potentially high-grade lode targets highlighted by SAM geophysical survey data.

A total of 31 holes for 2,614 metres of drilling were successfully completed during the first phase of the program.

Re-examination of data from a sub-audio magnetic (SAM) geophysical survey commissioned by the Company highlighted a potential southern extension of the main Steam Engine Lode, including several other previously unknown potential lode zones.

Advanced 3D modelling of the SAM geophysical data progressed and is nearing completion. The 3D modelling will enable accurate drill targeting of the SAM anomalies.

Revision of the 2021 Scoping Study continued during the period and was completed and announced to the market on 16 September 2024.

CORPORATE and COMMERCIAL

The Group completed one capital raising during the fourth calendar Quarter of 2023 comprising a placement of 166,666,667 ordinary shares at a price of \$0.012.

Each of the shares subscribed for were entitled to options on a 2:1 basis resulting in the issue of 83,333,333 options for no consideration with an expiry date of 31 December 2025 and an exercise price of \$0.04.

CASH CONSERVATION

The Company's Board maintains the current cash conservation measures concerning the Company's head office and administration.

The likelihood of realising forward gold prices is difficult. The actual price of gold at any point in the future depends on numerous foreseeable and unforeseeable factors.

Results from exploration activities are difficult to predict in advance and are uncertain.

REGULATORY MATTERS

The Group's operations are subject to substantial and significant regulatory control under various Queensland State and Commonwealth legislation. Significant matters that are regulated include mining, environmental, native title and real property. No matters of material concern have arisen in relation to regulatory control up to the date of this Report.

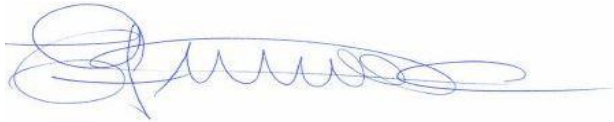

NOTES TO THE CONSOLIDATED FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE 2024

1. General Information

Superior Resources Limited (**Company**) is a company limited by shares, incorporated, and domiciled in Australia. The Company's shares are listed on the Australian Securities Exchange.

The financial statements are for the Group consisting of Superior Resources Limited and its subsidiaries (the **consolidated entity** or the **Group**).

2. Material Accounting Policy Information

(a) *Statement of compliance*

These financial statements are general purpose financial statements which have been prepared in accordance with the Corporations Act 2001, Australian Accounting Standards and Interpretations of the Australian Accounting Standard Board and in compliance with International Financial Reporting Standards ('IFRS') as issued by the International Accounting Standards Board. The Group is a for-profit entity for financial reporting purposes under Australian Accounting Standards. Material accounting policies adopted in the preparation of these financial statements are presented below and have been consistently applied unless stated otherwise.

The financial statements were authorised for issue by the Directors on 26 September 2024.

(b) *Basis of preparation*

Except for cash flow information, the financial statements have been prepared on an accrual basis and are based on historical costs, modified, where applicable, by the measurement at fair value of selected financial assets and financial liabilities.

(c) *Principles of consolidation*

The consolidated financial statements incorporate all of the assets, liabilities and results of the Parent (Superior Resources Limited) and all of the subsidiaries (including any structured entities). Subsidiaries are entities the Parent controls. The Parent controls an entity when it is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. A list of the subsidiaries or controlled operations is provided in Note 26.

The assets, liabilities and results of all subsidiaries are fully consolidated into the financial statements of the Group from the date on which control is obtained by the Group. The consolidation of a subsidiary is discontinued from the date that control ceases. Intercompany transactions, balances and unrealised gains or losses on transactions between Group entities are fully eliminated on consolidation. Accounting policies of subsidiaries have been changed and adjustments made where necessary to ensure uniformity of the accounting policies adopted by the Group.

The acquisition method of accounting is used to account for business combinations by the Group.

Non-controlling interests in the results and equity of subsidiaries are shown separately in the consolidated statement of profit or loss, statement of other comprehensive income, statement of changes in equity and statement of financial position, respectively.

(d) *Income Tax*

The income tax expense or revenue for the period is the tax payable on the current period's taxable income based on the applicable income tax rate for each jurisdiction adjusted by changes in deferred tax assets and liabilities attributable to temporary differences and to unused tax losses.

Deferred income tax is provided in full, using the liability method, on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the financial statements. However, the deferred income tax is not accounted for if it arises from initial recognition of an asset or liability in a transaction other than a business combination that at the time of the transaction affects neither accounting nor taxable profit or loss. Deferred income tax is determined using tax rates (and laws) that have been enacted or substantially enacted by the reporting date and are expected to apply when the related deferred income tax asset is realised or the deferred income tax liability is settled.

Deferred tax assets are recognised for deductible temporary differences and unused tax losses only if it is probable that future taxable amounts will be available to utilise those temporary differences and losses.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to offset current tax assets and liabilities and when the deferred tax balances relate to the same taxation authority. Current tax assets and tax liabilities are offset where the entity has a legally enforceable right to offset and intends either to settle on a net basis, or to realise the assets and settle the liability simultaneously.

Current and deferred tax is recognised in profit or loss, except to the extent that it relates to items recognised in other comprehensive income or directly in equity. In this case, the tax is also recognised in other comprehensive income or directly in equity, respectively.

(e) *Cash and cash equivalents*

For the consolidated statement of cash flows presentation purposes, cash and cash equivalents includes cash on hand and deposits held at call with financial institutions, other short-term, highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value, and bank overdrafts.

(f) Financial instruments

Initial Recognition and Measurement

Financial assets and financial liabilities are recognised when the Group becomes a party to the contractual provisions of the financial instrument. Financial assets will be recognised on the date that the Group becomes contractually bound to the relevant asset purchase or sale transaction (i.e. trade date accounting is adopted).

Financial instruments (except for trade receivables) are initially measured at fair value plus transaction costs, except where the instrument is classified "at fair value through profit or loss", in which case transaction costs are expensed to profit or loss immediately. Where available, quoted prices in an active market are used to determine fair value. In other circumstances, valuation techniques are adopted.

Trade receivables are initially measured at the transaction price if the trade receivables do not contain a significant financing component or if the practical expedient was applied as specified in paragraph 63 of AASB 15: *Revenue from Contracts with Customers*.

Classification and Subsequent Measurement

Financial assets

Financial assets are subsequently measured at:

- amortised cost;
- fair value through other comprehensive income; or
- fair value through profit and loss.

Measurement is on the basis of the two primary criteria, being:

- the contractual cash flow characteristics of the financial asset; and
- the business model for managing the financial assets.

A financial asset that meets the following conditions is subsequently measured at amortised cost:

- the financial asset is managed solely to collect contractual cash flows; and
- the contractual terms within the financial asset give rise to cash flows that are solely payments of principal and interest on the principal amount outstanding on specified dates.

A financial asset that meets the following conditions is subsequently measured at fair value through other comprehensive income:

- the contractual terms within the financial asset give rise to cash flows that are solely payments of principal and interest on the principal amount outstanding on specified dates; and
- the business model for managing the financial assets comprises both contractual cash flows collection and the selling of the financial asset.

By default, all other financial assets that do not meet the measurement conditions of amortised cost and fair value through other comprehensive income are subsequently measured at fair value through profit or loss.

Financial liabilities

Financial liabilities are subsequently measured at:

- amortised cost; or
- fair value through profit and loss.

A financial liability is measured at fair value through profit and loss if the financial liability is:

- a contingent consideration of an acquirer in a business combination to which AASB 3 Business Combinations applies;
- held for trading; or
- initially designated as at fair value through profit or loss.

All other financial liabilities are subsequently measured at amortised cost using the effective interest method.

Equity instruments

At initial recognition, as long as the equity instrument is not held for trading and not a contingent consideration recognised by an acquirer in a business combination to which AASB 3 Business Combinations applies, the Group made an irrevocable election to measure any subsequent changes in fair value of the equity instruments in other comprehensive income, while the dividend revenue received on underlying equity instruments investment will still be recognised in profit or loss.

Regular way purchases and sales of financial assets are recognised and derecognised at settlement date in accordance with the Group's accounting policy.

Derecognition

Derecognition refers to the removal of a previously recognised financial asset or financial liability from the statement of financial position.

Derecognition of financial liabilities

A liability is derecognised when it is extinguished (i.e. when the obligation in the contract is discharged, cancelled or expires). An exchange of an existing financial liability for a new one with substantially modified terms or a substantial modification to the terms of a financial liability, is treated as an extinguishment of the existing liability and recognition of a new financial liability.

The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable, including any non-cash assets transferred or liabilities assumed, is recognised in profit or loss.

Derecognition of financial assets

A financial asset is derecognised when the holder's contractual rights to its cash flows expires, or the asset is transferred in such a way that all the risks and rewards of ownership are substantially transferred.

All the following criteria need to be satisfied for derecognition of financial assets:

- the right to receive cash flows from the asset has expired or been transferred;
- all risk and rewards of ownership of the asset have been substantially transferred; and
- the Group no longer controls the asset (i.e. no practical ability to make unilateral decision to sell the asset to a third party).

Impairment

The Group recognises a loss allowance for expected credit losses on:

- financial assets that are measured at amortised cost or fair value through other comprehensive income;
- lease receivables;
- contract assets (e.g. amount due from customers under construction contracts); loan commitments that are not measured at fair value through profit or loss; and financial guarantee contracts that are not measured at fair value through profit or loss.

Loss allowance is not recognised for:

- financial assets measured at fair value through profit or loss; or
- equity instruments measured at fair value through other comprehensive income.

Recognition of expected credit losses in financial statements

The carrying amount of financial assets measured at amortised cost includes the loss allowance relating to that asset.

Assets measured at fair value through other comprehensive income are recognised at fair value, with changes in fair value recognised in other comprehensive income. Amounts in relation to change in credit risk are transferred from other comprehensive income to profit or loss at every reporting period.

For financial assets that are unrecognised (e.g. loan commitments yet to be drawn, financial guarantees), a provision for loss allowance is created in the statement of financial position to recognise the loss allowance.

(g) Trade and other payables

These amounts represent liabilities for goods and services provided to the company prior to the end of the financial year which are unpaid. The amounts are unsecured and are usually paid within 30 days of recognition.

(h) Exploration and evaluation assets

Exploration and evaluation costs are accumulated separately for each area of interest until such time as the area is abandoned or sold. The realisation of the value of the exploration and evaluation assets carried forward depends on any commercial results that may be obtained through successful development and exploitation of the area of interest or alternatively by its sale. If an area of interest is abandoned or is considered to be of no further commercial interest the accumulated exploration and evaluation assets relating to the area are written off against income in the year of abandonment. Some exploration and evaluation assets may also be written off where areas of interest are partly relinquished and in cases where uncertainty exists as to the value, provisions for possible diminution in value are established.

When production commences, the accumulated costs for the relevant area of interest are amortised over the life of the area according to the rate of depletion of the economically recoverable reserves.

A regular review is undertaken of each area of interest to determine the appropriateness of continuing to capitalise costs in relation to that area.

(i) **Contributed equity**

Ordinary shares are classified as equity.

Incremental costs directly attributable to the issue of new shares or options are shown in equity as a deduction, net of tax, from the proceeds.

(j) **Dividends**

Provision is made for the amount of any dividend declared, being appropriately authorised and no longer at the discretion of the entity, on or before the end of the financial year but not distributed at balance date.

(k) **Earnings per share**

Basic earnings per share

Basic earnings per share is calculated by dividing the profit or loss attributable to equity holders of the Group, excluding any costs of servicing equity other than ordinary shares, by the weighted average number of ordinary shares outstanding during the financial year, adjusted for bonus elements in ordinary shares issued during the year.

Diluted earnings per share

Diluted earnings per share adjusts the figures used in the determination of basic earnings per share to take into account the after income tax effect of interest and other financing costs associated with dilutive potential ordinary shares and the weighted average number of shares assumed to have been issued for no consideration in relation to dilutive potential ordinary shares.

(l) **Employee benefits**

Short-term obligations

Liabilities for wages and salaries, including non-monetary benefits, annual leave and accumulating sick leave, which are expected to be settled within 12 months after the end of the period in which the employees render the related services, are recognised in respect of employees' services up to the end of the reporting period and are measured at the amounts expected to be paid when the liabilities are settled. The liability for annual leave is recognised in the provision for employee entitlements. All other short-term employee benefit obligations are presented as payables.

Other long-term employee benefit obligations

The liability for long service leave and annual leave which is not expected to be settled within 12 months after the end of the period in which the employees render the related services, is recognised in the provision for employee benefits and measured as the present value of expected future payments to be made in respect of services provided by employees up to the end of the reporting period. Consideration is given to expected future wage and salary levels, employee departures and periods of service.

Expected future payments are discounted using market yields at the end of the reporting period on government bonds with terms and currencies that match, as closely as possible, the estimated future cash outflows.

The obligations are presented as current liabilities in the statement of financial position if the entity does not have an unconditional right to defer settlement for at least twelve months after the reporting date, regardless of when the actual settlement is expected to occur.

(m) Parent entity financial information

The financial information for the parent entity, Superior Resources Limited, disclosed in note 28 has been prepared on the same basis as the consolidated financial statements.

(n) Comparative Figures

When required by Australian Accounting Standards, comparative figures have been adjusted to conform to changes in presentation for the current financial year.

Where the Group retrospectively applies an accounting policy, makes a retrospective restatement or reclassifies items in its financial statements, an additional (third) statement of financial position as at the beginning of the preceding period in addition to the minimum comparative financial statements is presented.

(o) Fair Value of Assets and Liabilities

The Group measures some of its assets and liabilities at fair value on either a recurring or non-recurring basis, depending on the requirements of the applicable Accounting Standard.

Fair value is the price the Group would receive to sell an asset or would have to pay to transfer a liability in an orderly (i.e. unforced) transaction between independent, knowledgeable and willing market participants at the measurement date.

As fair value is a market-based measure, the closest equivalent observable market pricing information is used to determine fair value. Adjustments to market values may be made having regard to the characteristics of the specific asset or liability. The fair values of assets and liabilities that are not traded in an active market are determined using one or more valuation techniques. These valuation techniques maximise, to the extent possible, the use of observable market data.

To the extent possible, market information is extracted from either the principal market for the asset or liability (i.e. the market with the greatest volume and level of activity for the asset or liability) or, in the absence of such a market, the most advantageous market available to the entity at the end of the reporting period (i.e. the market that maximises the receipts from the sale of the asset or minimises the payments made to transfer the liability, after taking into account transaction costs and transport costs).

For non-financial assets, the fair value measurement also takes into account a market participant's ability to use the asset in its highest and best use or to sell it to another market participant that would use the asset in its highest and best use.

The fair value of liabilities and the entity's own equity instruments (excluding those related to share-based payment arrangements) may be valued, where there is no observable market price in relation to the transfer of such financial instruments, by reference to observable market information where such instruments are held as assets. Where this information is not available, other valuation techniques are adopted and, where significant, are detailed in the respective note to the financial statements.

(p) Impairment of Non-financial Assets

At the end of each reporting period, the Group assesses whether there is any indication that a non-financial asset may be impaired. The assessment will include the consideration of external and internal sources of information including dividends received from subsidiaries, associates or joint ventures deemed to be out of pre-acquisition profits. If such an indication exists, an impairment test is carried out on the asset by comparing the recoverable amount of the asset, being the higher of the asset's fair value less costs of disposal and value in use, to the asset's carrying amount. Any excess of the asset's carrying amount over its recoverable amount is recognised immediately in profit or loss, unless the asset is carried at a revalued amount in accordance with another Standard (for example in accordance with the revaluation model in AASB 116: Property, Plant and Equipment). Any impairment loss of a revalued asset is treated as a revaluation decrease in accordance with that other Standard.

Where it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the cash-generating unit to which the asset belongs.

When an impairment loss subsequently reverses, the carrying amount of the asset (or cash-generating unit) is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset (or cash-generating unit) in prior years. A reversal of an impairment loss is recognised immediately in profit or loss, unless the relevant asset is carried at a revalued amount, in which case the reversal of the impairment loss is treated as a revaluation increase.

The Group does not actively engage in the trading of financial assets for speculative purposes nor does it write options. The most significant financial risks to which the Group are exposed are credit risk, liquidity risk, market risk and cash flow interest rate risk.

5. Critical Accounting Estimates and Judgements

Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that may have a financial impact on the entity and that are believed to be reasonable under the circumstances.

Critical judgements in applying the entity's accounting policies

The Group has capitalised non-current exploration expenditure of \$15,155,253 (2023: \$11,769,482).

This amount includes costs directly associated with exploration. These costs are capitalised as an intangible asset until assessment of the permit is complete and the results have been evaluated. These costs include direct employee remuneration, materials, drilling costs, delay costs, rental payments and payments to contractors. The expenditure is carried forward until such a time as the asset moves into the development phase, is abandoned or sold. Given exploration activities have not yet reached a stage which permits a reasonable assessment of the existence or otherwise of recoverable resources and the difficulty in forecasting cash flows to assess the fair value of exploration expenditure, there is uncertainty as to the carrying value of exploration expenditure. The ultimate recovery of the carrying value of exploration expenditure is dependent upon the successful development and commercial exploitation or, alternatively, sale of the Group's interest in the tenements.

6. Going Concern Principle

Notwithstanding that the Group incurred an operating loss after tax of \$1,408,348 (2023: loss of \$889,011) and a net cash outflow from operating activities of \$1,288,218 (2023: \$953,804) these financial statements have been prepared on a going concern basis which assumes continuity of normal business activities and the realisation of assets and the settlement of liabilities in the ordinary course of business for the foreseeable future.

The ability of the Group to continue as a going concern depends on one or more of the following:

- obtaining additional funding from capital raising activities;
- achieving sufficient future cash flows from operations to enable its obligations to be met;
- the success of cost saving initiatives, which include entering into Joint Venture arrangements and reducing tenement areas, so as to reduce the carrying and expenditure costs for tenements; and
- cash flows from the sale of any of the Group's assets.

On 13 September 2024 the Group issued 168,643,380 shares raising \$1,180,504 before issue cost. The Directors acknowledge that to continue the exploration and development of the Group's exploration projects, the budgeted cash flows from operating and investing activities for the future will necessitate further capital raisings.

At the date of this Report and having considered the above factors, the Directors consider that the Group will be able to continue as a going concern and will be able to pay its debts as and when they fall due and payable.

The reliance on securing additional capital gives rise to the existence of a material uncertainty that may cast significant doubt on the Group's ability to continue as a going concern with the result that the Group may be required to realise its assets at amounts different from those currently recognised, settle liabilities other than in the ordinary course of business and make provisions for costs which may arise as a result of cessation or curtailment of normal business operations.

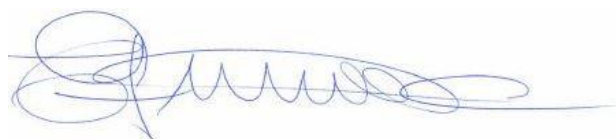
