Private Placement - Information required by ASX Listing Rule 3.10.5A

Motopia Limited (Company) today announced a private placement of 125,384,614 shares in the Company (Shares) raising \$81,500 before costs. The Shares were issued pursuant to ASX Listing Rule 7.1 and 7.1A. It is intended that funds raised from the private placement will be used for working capital purposes and to fund CU2 Global Pty Ltd and ConvertU2 Technologies Pty Ltd.

In accordance with ASX Listing Rule 3.10.5A the following information is provided to the ASX in relation to the issue of 41,800,000 Shares from the private placement that were issued pursuant to ASX Listing Rule 7.1A.

1. The issue of 41,800,000 Shares pursuant to ASX Listing Rule 7.1A raised \$31,350 before costs and diluted the voting power of existing shareholders by 0.86%.
2. The Company elected to issue the Shares as a placement under Listing Rule 7.1A rather than a pro rata issue (or other type of issue) due to the cost and timing benefits of a private placement.
3. There was no underwriting agreement in connection with the placement.
4. The Company incurred a broker commission fee equal to 8% of funds raised.
