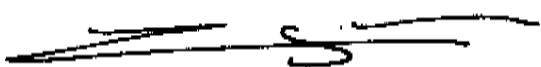

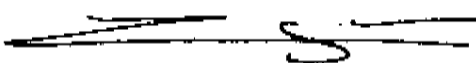

DIRECTIONS

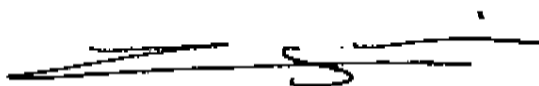
