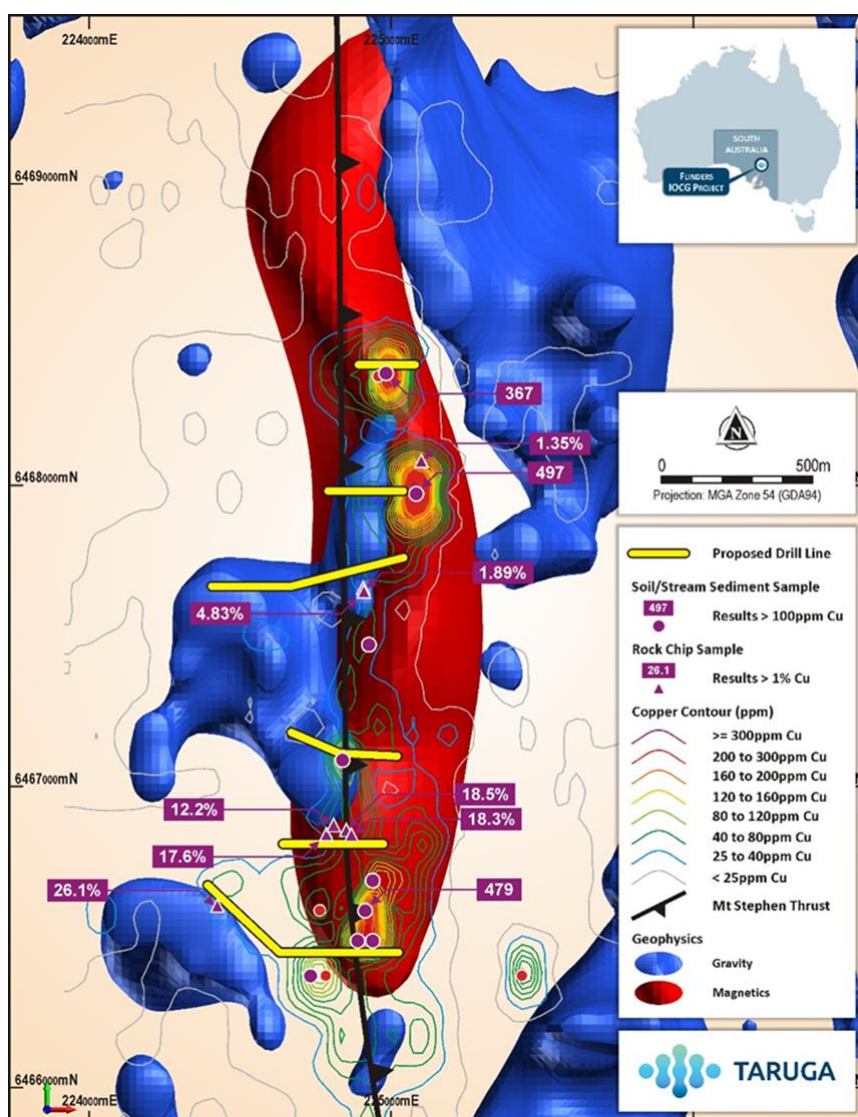

Drilling Commences at Flinders IOCG Project, SA

Taruga Minerals Limited (**Taruga** or the **Company**) is pleased to announce that the Aircore drilling program has commenced at Woolshed/Metabase prospects at the Flinders IOCG project. It is expected that drill holes will attain depths of between 50 to 80m which will give a clear indication of potential mineralisation below surface which will be followed up with RC drilling. The first drill fence will cover the historic Woolshed workings which reported highly significant rock chip (up to **18.5% Cu**) and soil results shown in **Figure 1**. All holes will be drilled using Aircore hammer due to drilling in hard rock formation.
