NON-RENOUNCEABLE RIGHTS ISSUE

Tasman has made good progress with its exploration programme at Vulcan, having now drilled eight widely spaced drill holes into this huge 12 square kilometre target, and having encountered an Olympic Dam style iron oxide/ copper/ gold/ uranium (IOCGU) system in all holes.

The key features of the exploration to date include:

- the Vulcan exploration target is of a similar area to the Olympic Dam deposit, 30 kilometres away;
- the discovery in our last hole, VUD 8 of the existence of bornite (a copper mineral that is associated with the high grade zones at Olympic Dam);
- a 155 metre intersection in VUD 7 of classic Olympic Dam style pyrite/ chalcopyrite hematite breccia ;
- narrower zones of high grade copper mineralisation (up to 7% copper in one narrow intersection) in VUD 3, and
- the repeated confirmation from many of the holes of the regular occurrence of all the same minerals that occur at Olympic Dam, including iron (predominately hematite), copper, gold, uranium, silver, rare earths, molybdenum and barium, in places.

However, Tasman has to date been prevented from drilling on the most prospective southern part of the Vulcan system due to the existence of a large Aboriginal Heritage site that has been noted over the area, and, after a long period of consultation with the Government , we now propose to try and resolve this matter firstly by consultation if possible, or if not, by seeking to have the issue determined under the provisions of the South Australian Aboriginal Heritage legislation.

Further, Eden Energy Ltd (Eden), which Tasman incorporated in 2004 and of which Tasman (through its wholly owned subsidiary, Noble Energy Pty Ltd) is the largest shareholder, holding a strategic 16% shareholding, has also been making significant progress with its development and rollout of its clean energy projects, which are starting to now generate cashflow, and is undertaking a rights issue in order to raise funds to progress these projects.

In particular, Eden's new pyrolysis project, that produces hydrogen and carbon nanotubes and carbon nanofibres from natural gas, is showing great promise, with Eden having achieved its first commercial sale to a battery manufacturer of carbon Eden has produced. Further initial tests have produced very impressive improvement in the compressive strength of concrete with the addition of a small quantity of carbon fibres and strong interest has been shown by several Indian concrete manufacturers in testing this.

For these reasons, Tasman's directors have decided to support the Eden rights issue and to also sub-underwrite up to a further \$550,000 of shares offered under the Eden rights issue.

To provide the necessary funds for the above matters, the directors of Tasman have decided to undertake a further non-renounceable, pro-rata rights issue, in which the directors have all indicated that they currently intend to take up their entitlements, and I invite all shareholders to consider this opportunity carefully and hopefully support the issue. The directors have reserved the right to place any shortfall should that occur.

2.18. EXISTING UNLISTED OPTIONS

Holders of the existing Options (listed and unlisted) may participate in this Offer by exercising any or all of their Options prior to the Record Date.
