Commentary

Australian Renewable Fuels Limited (ARfuels) presents its Appendix 4C: Consolidated Statement of Cash Flows for the September 2015 quarter. Key highlights for the quarter include:

- Net operating cash inflows of \$0.54m for the quarter ending 30 September 2015.
- Planned investment in property, plant and equipment of \$0.414m for the quarter resulted in a net cash inflow of \$0.126m.

ARfuels reports a cash at bank position of \$1.873m as at 30 September 2015 and an undrawn debt facility of \$5.5m.

Further commentary regarding the current performance of the business will be made in the Annual General Meeting on 23 October 2015 at 11am, Level 25, 600 Bourke Street, Melbourne.

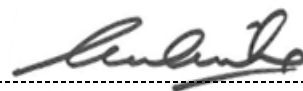
