TEK is undertaking a placement (in 2 tranches) to institutional, sophisticated and professional investors to raise up to approximately \$25.3 million. The first tranche will raise approximately \$21.7 million. The second tranche will raise up to approximately \$3.6 million and is subject to shareholder approval (and in respect of Thorney Group's proposed participation in the placement, subject to receipt of ASIC relief as described in the investor presentation lodged with ASX the date of this Appendix 3B).
