

MARE GROUP REQUESTS CORRECTION FROM ELES REGARDING THE AUGUST 5, 2025 RELEASE

Clarification also requested regarding changes involving other significant shareholders

Salerno, August 7, 2025

Mare Group S.p.A. (ticker **MARE.MI**), an engineering company listed on Euronext Growth Milan and active in Italy and abroad in innovation through enabling technologies ("**Mare Group**"), in relation to the press release issued by Eles Semiconductor Equipment S.p.A. ("**Eles**") on August 5, 2025 ([link](#)), states that it has **not submitted to Eles any notification concerning a material change in significant shareholding** and has therefore sent Eles a **formal request for correction** as of today.

Based on the final results of the OPAS on Eles, published on 6 August 2025, Mare Group will reach a stake equal to 29.04% of Eles's share capital and 28.22% of voting rights upon settlement of the Offer and payment of the consideration, scheduled for 8 August 2025.

In the same request, Mare Group also invited Eles to **disclose to the market**, in accordance with current transparency obligations, **any further changes concerning other significant shareholders** whose holdings appear to have been reduced between the press release dated **July 2, 2025** and the one published on **August 5, 2025**.
