Notice under Section 708A

Paringa Resources Limited ("Company") has today issued 36,800,000 fully paid ordinary shares. The issued securities are part of a class of securities quoted on the Australian Securities Exchange ("ASX").

The Company hereby notifies ASX under paragraph 708A(5)(e) of the Corporations Act 2001 (Cwth) (the "Act") that:

1. the Company issued the securities without disclosure to investors under Part 6D.2 of the Act;

Information required under ASX Listing Rule 3.10.5A

- (a) Paringa Resources Limited ("Company") has today issued 15,489,900 shares under Listing Rule 7.1A to new shareholders. Dilution to existing shareholders as a result of the issue under Listing Rule 7.1A is 9.1%. The percentage of the post-placement issued capital (excluding any new shares issued by the Company under Listing Rule 7.1) held by the pre-placement shareholders is 90.9%.
- (b) The Company issued shares under Listing Rule 7.1A because the placement under Listing Rule 7.1A was considered to be a more efficient mechanism for raising funds. The placement did not expose the Company to additional costs, a protracted process and market volatility that may have been experienced with a pro-rata issue or other type of issue in which existing ordinary shareholders would have been eligible to participate;
- (c) No underwriting arrangements are in place for the placement under Listing Rule 7.1A; and
- (d) A fee of up to 5% may be paid to brokers in connection with the placement under Listing Rule 7.1A.
