Beatty Park Sth Drilling Continues

Tambourah Metals Limited (**ASX:TMB**) is pleased to advise contracts have been signed for 3,000m of aircore drilling targeting high-grade gold, at Beatty Park Sth, along strike from intersections reported from BPAC016 (**6m at 25.8g/t Au from 30m, including 1m at 126g/t Au from 30m¹**) and BPAC028 (**24m at 18.8g/t Au from 20m in BPAC028, including 4m at 92.2g/t Au from 24m and 4m at 14.3g/t Au from 28m²**).

The Company's emerging high grade gold discovery is located 160km north of Meekatharra, Western Australia (Figure 2).

The aircore program is expected to commence shortly and will focus on outlining the extent of shallow, high-grade gold mineralisation. It will also provide additional information for planned RC drilling of deeper, bedrock targets. Tambourah has submitted a POW for follow-up RC drilling and approval for this program is pending.

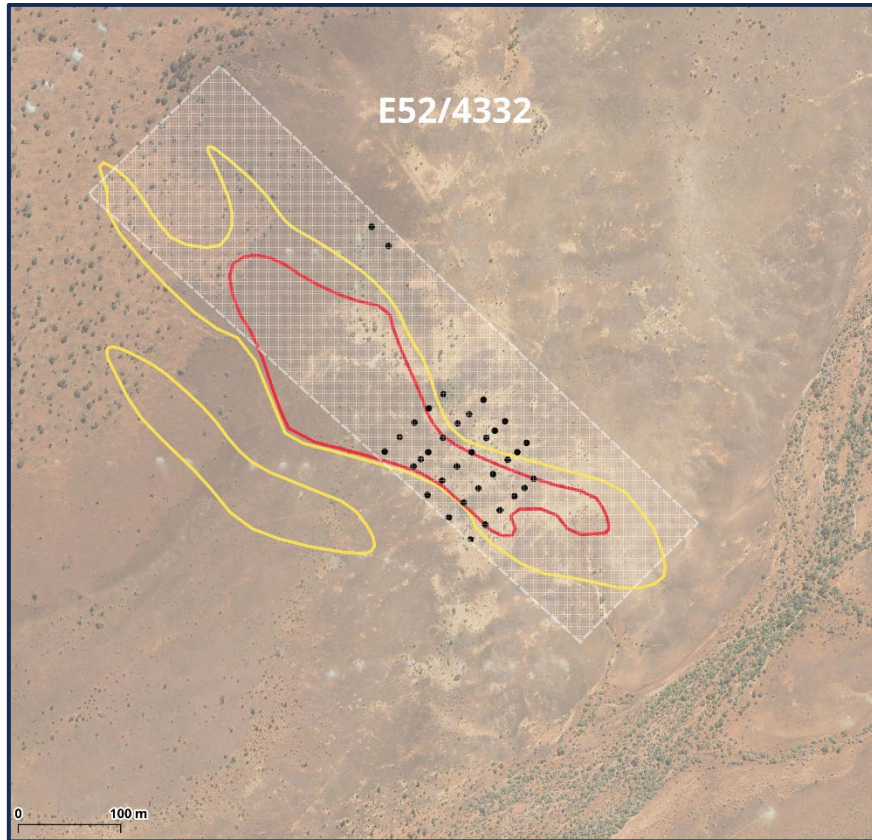


Figure 1 Beatty Park Sth soil anomaly showing extent of planned aircore drilling (white outline). (TMB drill collars -black).

First-pass drilling over the northern extent of the gold in soil anomaly, 300m northwest of current drilling, is planned as part of this program (see Figure 1). Samples will be dispatched from site for assay regularly and results are expected to be available within 4-5 weeks.

Tambourah Executive Chairperson Rita Brooks commented *"We are pleased with the high level of interest following our recent gold drill results from Beatty Park Sth. As a result, we have raised funds to accelerate the exploration programs and we welcome new shareholders and the Tribeca Investment Partners onto the share register"*.

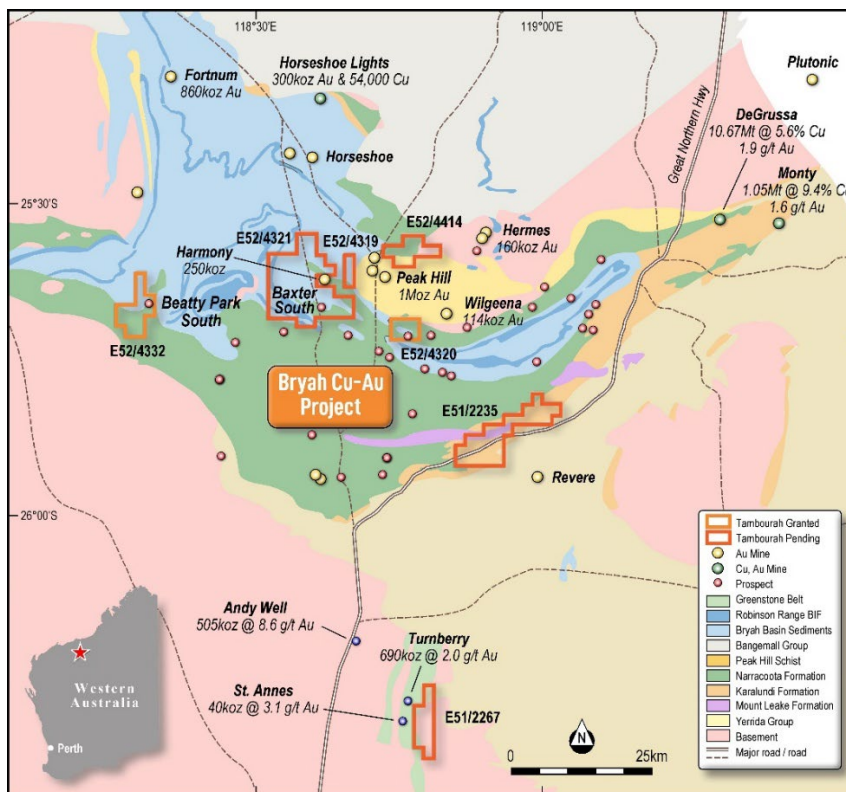


Figure 2 Tenement location plan showing Beatty Park Sth E52/4332.
