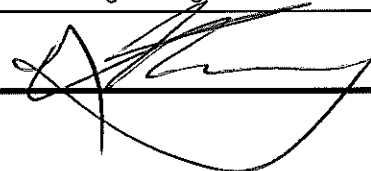

## DIRECTIONS
