The Board of Directors ("Board") of TNG Limited ("TNG" or the "Company") is responsible for the corporate governance of the Company. The Board guides and monitors the business and affairs of the Company on behalf of the shareholders by whom they are elected and to whom they are accountable.

This Corporate Governance Statement ("Statement") sets out the Company's main corporate governance practices in place during the financial year end 30 June 2019, with reference to the *Corporate Governance Principles and Recommendations 3rd Edition* of the ASX Corporate Governance Council.

This Statement was approved by the Board and is current as at 26 September 2019.

The Company does not have any female Board members or senior managers (2018: nil). Of the balance of the Company's employees, 56% are female (2018: 57%). In total, 42% of the Company's employees, including Directors, are female (2018: 42%).
