

**Initial Nxuu Polymetallic Zn/Pb/Ag/V2O5/Ge/Ga Deposit Mineral Resource Estimate  
Compliant with the 2012 JORC Code**

**HIGHLIGHTS**

Mineralisation at the Nxuu Deposit occurs within a totally oxidised Quartz Wacke, within a shallow barren Dolostone basin, below Kalahari sand cover.

Applying low cuts of 0.5% for Zn, 0.5% for Pb, 10g/t for Ag, 300ppm for V2O5, 3g/t for Ge and 10g/t for Ga, data from 70 drill holes was assembled for an **initial Indicated/Inferred Mineral Resource Estimate of 6 million tonnes** containing **Zn/Pb/Ag/V2O5/Ge/Ga** at an average **Zn Equivalent Grade of 1.8%**, applying a **Zn Equivalent 0.5% low cut for the Nxuu Deposit**.

**Of significance is the high volume of mineralised content of the Nxuu Deposit, being 83.4% , included in the Mineral Resource Estimate (Ref Table 3)**

- The 70 drill holes totalled 3,384m to the end of holes, averaging 48.34m per hole
- **2,822m (83.4%)** contained above low-cut mineralisation, averaging 40.31m per hole are included in the Mineral Resource Estimate
- Of the remaining 562m (16.6%), **234m (6.9%)** consisted of Kalahari sand cover
- Only **328m (9.7%)** are below low-cut grade or barren Quartz Wacke
- **The 6 million tonnes (Ref Table 1) are made up of:**
  - (a) An **Indicated** Zn/Pb/Ag/V2O5/Ge/Ga Mineral Resource Estimate of **2.7 million tonnes**, within the Zn/Pb/Ag domains
  - (b) An **Inferred** Zn/Pb/Ag/V2O5/Ge/Ga Mineral Resource Estimate of **2.9 million tonnes**, within the Zn/Pb/Ag domains
  - (c) An additional **Inferred** Vanadium (V/V2O5) Mineral Resource Estimate of **0.4 million tonnes**, outside of the Zn/Pb/Ag domains
- **The 6 million tonnes (Ref Table 1) contain the following metal content:**
  - (a) **64,000 tonnes of Zn**
  - (b) **32,000 tonnes of Pb**
  - (c) **1,040,000 ounces of Ag**
  - (d) **2,600 tonnes of V2O5**
  - (e) **16,000 kg of Ge**
  - (f) **61,000 kg of Ga**

- **An additional initial Inferred Mineral Resource Estimate of 2.3 million tonnes of Ge/Ga** that surrounds the above 6 million tonnes Indicated/Inferred Mineral Resource Estimate.
- **The additional Inferred 2.3 million tonnes (Ref Table 2) are made up of:**
  - (a) **2.3 million tonnes of Ge @ an average grade of 1.4g/t.** Whilst normally applying a low cut of 3g/t for Ge, the 1.4g/t has been included as it is within the 11.3g/t domain of Ga
  - (b) **2.3 million tonnes of Ga @ an average grade of 11.3g/t,** applying a low cut of 10g/t
- **The additional 2.3 million tonnes (Ref Table 2) contained the following metals:**
  - (c) **3,200 kg of Ge**
  - (d) **25,500 kg of Ga**

#### **Combined In-ground Metal Content of the Kihabe and Nxuu Resources**

The Kihabe Indicated/Inferred Mineral Resource Estimate was released to the market on 10 August 2022 and 31 October 2022 in the September Quarterly Report.

#### **Kihabe and Nxuu Indicated and Inferred Resources In-Ground Metal Content**

The Kihabe and Nxuu Mineral Resource Estimates include a combined tonnage of **29.5 million tonnes** at various grades of Zn/Pb/Ag/V2O5/Ge/Ga with the metal contents shown below.

# Nxuu Polymetallic Zn/Pb/Ag/V2O5/Ge/Ga Mineral Resource Estimate

An initial Indicated/Inferred Mineral Resource Estimate, compliant with the 2012 JORC Code, has been conducted on the Nxuu Deposit by independent Geological Consultant Shaun Searle (MAIG) of Ashmore Advisory Pty Ltd.

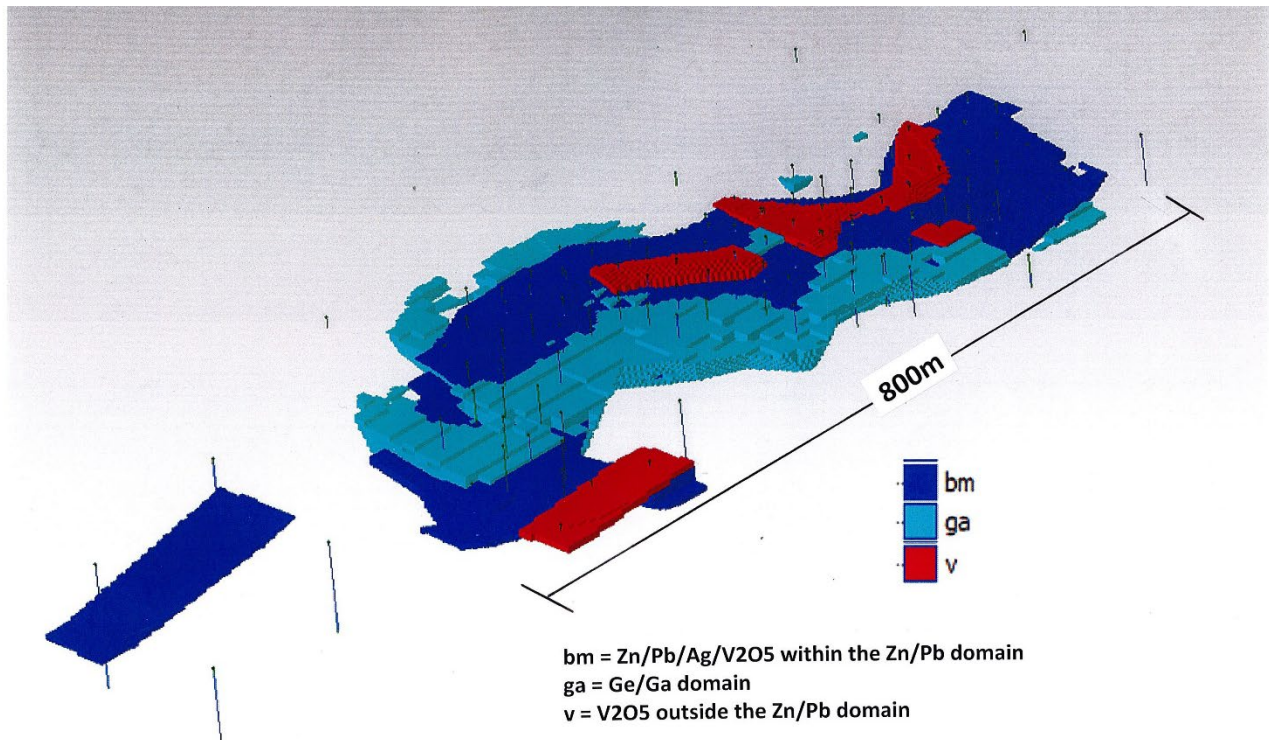

**Further Drilling Required at the Nxuu Deposit to conduct an Indicated/Measured Mineral Resource compliant with the 2012 JORC Code.**

Assay results from **four** HQ diamond core holes, announced to the market on 11 July 2022, have shown that mineralisation at the central West zone of the Nxuu Deposit extends further to the West than originally thought.

The **four** holes returned combined mineralised intersections of Zn/Pb/Ag/V2O5/Ge/Ga, as follows:

- NXDD104 had **19.93m** of combined mineralisation from 14.00m to 33.93m
- NXDD066A had **36.41m** of combined mineralisation from 14.00m to 50.41m
- NXDD105 had **24.37m** of combined mineralisation from 6.22m to 30.59m
- NXDD091A had **39.68m** of combined mineralisation from 19m to 58.68m

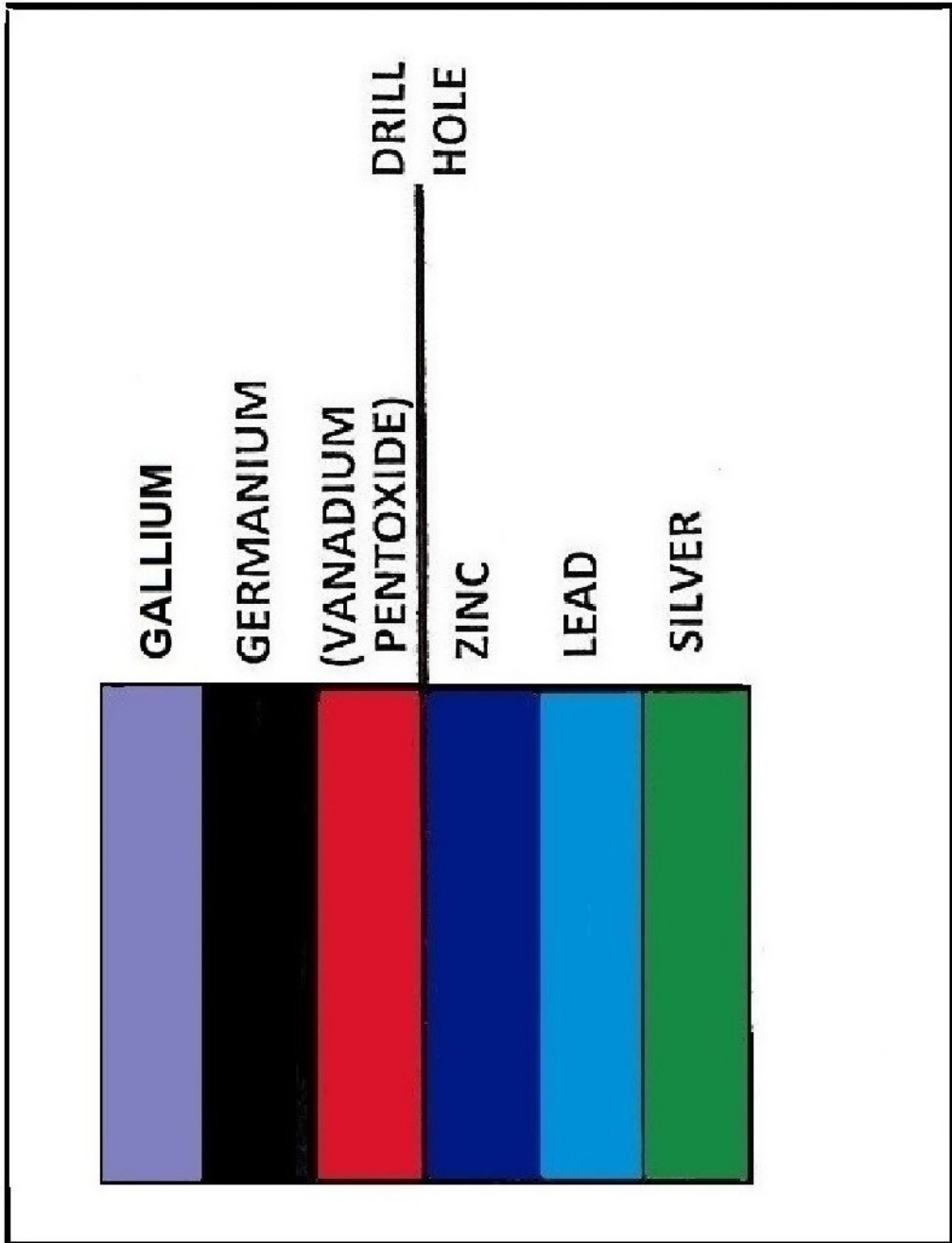
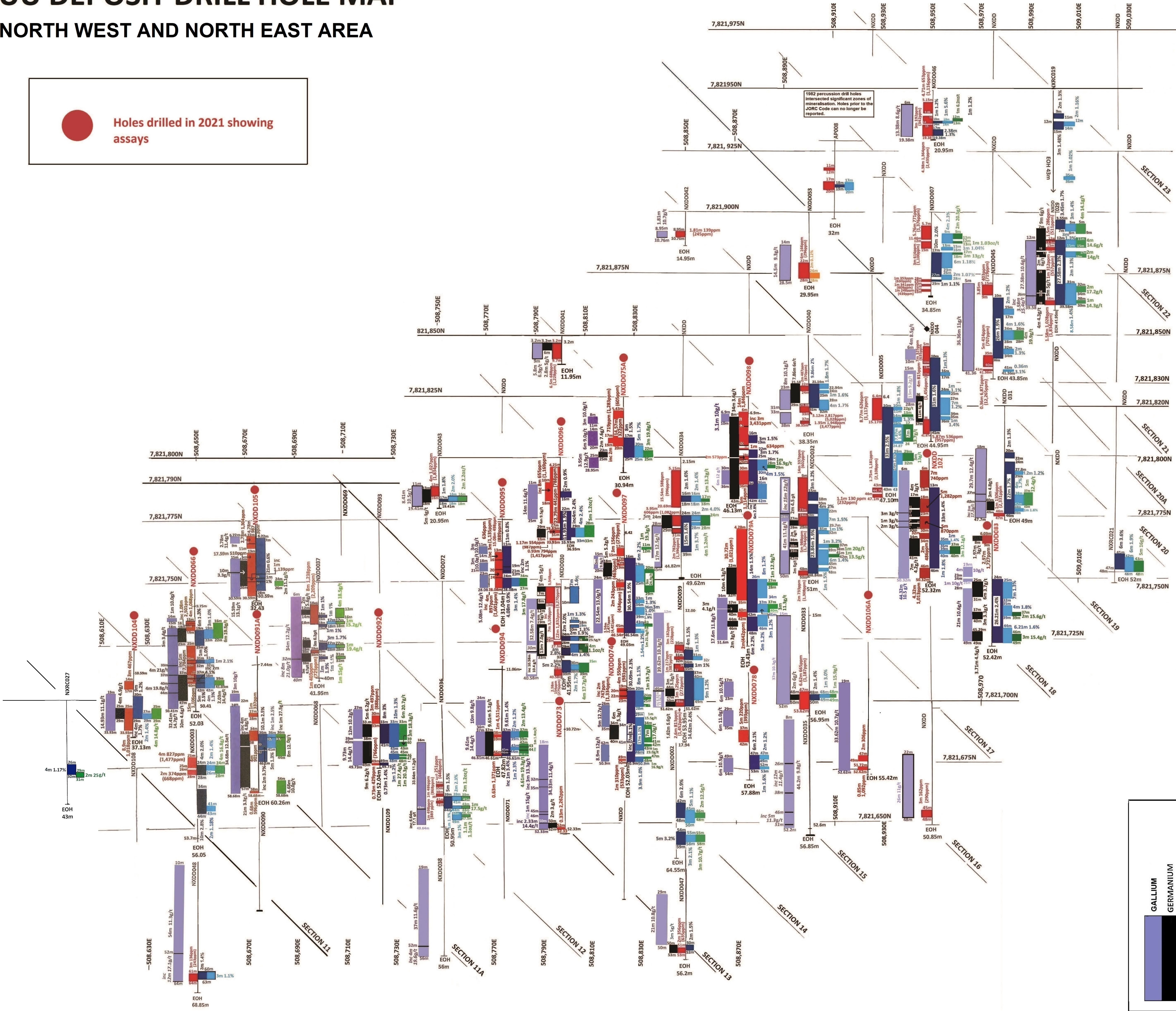
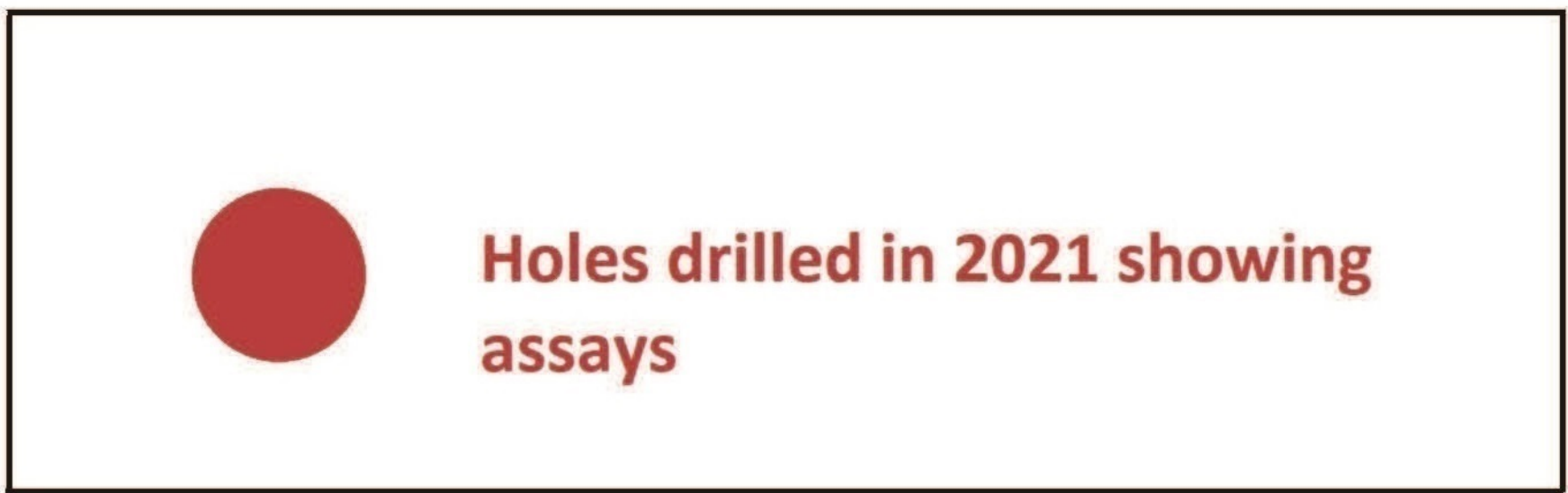
It was previously assumed that the combined mineralised intersections in this zone would be comparative to those of drill holes NXRC027 to the SW and NXDD043 to the NE, which were as follows:

- NXRC027 only had **5.00m** of combined mineralisation from 26.00m to 31.00m.
- NXDD043 only had **7.41m** of combined mineralisation from 12.00m to 19.41m.

With the significant increase in the mineralised intersections of the above four drill holes, extensional drilling will now be required to the West of the central West zone, not previously planned. Further planned drilling is also required in the SW zone and within the main central West and North-East zones. This drilling is estimated to require in the region of 2,600m of HQ diamond core.

## **Metal Content of Combined Kihabe and Nxuu Mineral Resource Estimates**

The combined Kihabe and Nxuu Mineral Resource Estimates contain the following metals:

- **385,000** tonnes of Zinc
- **186,000** tonnes of Lead
- **6,440,000** ounces of Silver
- **12,600** tonnes of Vanadium Pentoxide
- **19,200** kilos Germanium (Nxuu Deposit only)
- **86,500** kilos of Gallium (Nxuu Deposit only)

### **Kihabe Deposit Mineral Resource Estimate**

Significant intersections of Cu, Ge and Ga have been identified at the Kihabe Deposit, which included a continuous 91m intersection @ 12.6g/t Ga, in KDD201, however these metals have not been included in the Kihabe Mineral Resource Estimate. Further in-fill drilling is required to determine the continuity of Cu mineralisation for a Mineral Resource Estimate. Further in-fill drilling is also required to enable further assaying for Ge and Ga, which have only been included in assaying to a limited extent to date. Only then can Ge and Ga be included in the Mineral Resource Estimate.

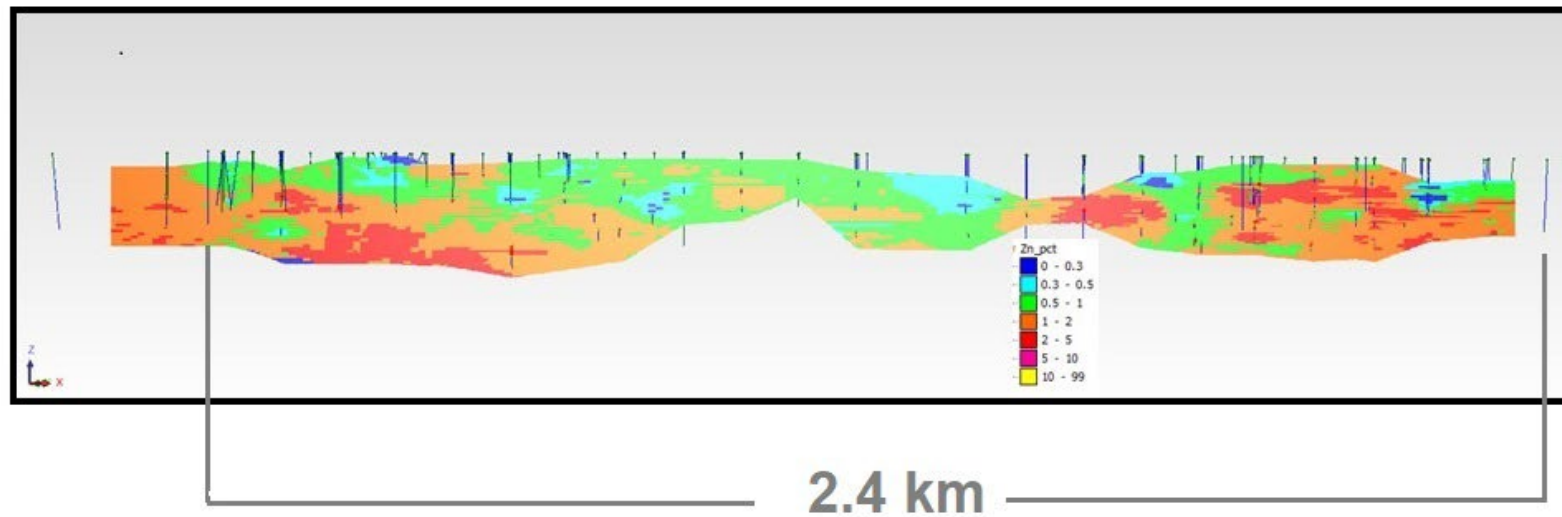

## **Nxuu Deposit Initial Mineral Resource Estimate**

### **Geology and Geological Interpretation**

The Nxuu deposit lies in the north-western part of Botswana at the southern margin of the Congo craton. To the north of the project are granitoids, ironstones, quartzites and mica schists of the Tsodilo Hills Group covered by extensive recent Cainozoic sediments of the Kalahari Group. Below the extensive Kalahari sediments are siliciclastic sediments and igneous rocks of the Karoo Supergroup in fault bounded blocks. The Nxuu deposit mineralisation occurs in a flat-lying quartz wacke unit situated on the contact of a barren dolomite basement unit. The deposit is weathered, with base metal mineralisation occurring as a series of sub-horizontal units overlying the barren dolomite unit.

### **Sampling and Sub-Sampling Techniques**

RC chips were collected over 1m intervals, and two-stage riffle split to produce a sample for dispatch to the assay laboratory. The remainder of the sample was bagged and kept on site for access pending assay results; with washed chip samples for each metre also collected in chip trays for logging and later reference.

Diamond core drilling was conducted from surface using HQ and NQ core diameter. Sampling is at 1m intervals or to geological contacts for mineralisation. The majority of core was split in half by core saw for external laboratory preparation and analysis.

HQ and NQ diamond core was marked and collected in sample trays, visually logged and cut in half. Samples were collected as nominal 1m intervals but based on visible geology with minimum samples of 0.3m and maximum samples of 1.3m. Half of each core was retained on site in core trays and the other half was double bagged and sent to Intertek Genalysis, Randburg, South Africa where they were crushed. A portion of each intersection sample was then pulverised to p80 75um and sent to Intertek Genalysis in Perth for assaying.

Individual meters of RC drill chips were bagged from the cyclone. These were then riffle split for storage in smaller bags, with selected drill chips being stored in drill chip trays. A trowel was used to select drill chip samples from sample bags to be packaged and sent to Intertek Genalysis, Randburg, South Africa where they were crushed. A portion of each intersection's sample was then pulverised to P80 75um and sent to Intertek Genalysis in Perth for assaying.

### **Drilling Techniques**

Drilling included RC drilling with 5.5 inch hammer and diamond core of HQ and NQ diameter with standard and/or triple tube.

### **Classification Criteria**

The Mineral Resource was classified as Indicated and Inferred Mineral Resource based on data quality, sample spacing, and lode continuity. The Indicated Mineral Resource was defined within areas of close spaced drilling of less than 30m by 30m, and where the continuity and predictability of the mineralised units was reasonable. The Inferred Mineral Resource was assigned to areas where drill hole spacing was greater than 30m by 30m and less than 60m by 60m; or where small, isolated pods of mineralisation occur outside the main mineralised zones.

## Sample Analysis Method

The majority of the MTB RC samples selected for assay were dispatched to the Ongopolo Laboratory situated in Tsumeb, Namibia for assaying, utilising a four-acid digest and ICP-OES analysis for V, Co, Cu, Zn, As, Mo, Ag, Cd, Sb, Pb, Bi.

For diamond drilling, samples were sent to Genalysis Laboratory in Perth for assaying, utilising a four-acid digest and ICPMS/OES for Ag/Pb/Zn/Cu/V/Ge/Ga.

## Estimation Methodology

The mineralisation was constrained by Mineral Resource outlines created in Surpac software, based on logged geology and mineralisation envelopes prepared using a nominal 0.5% combined Zn and Pb cut-off grade with a minimum down-hole length of 2m. The wireframes were applied as hard boundaries in the estimate.

Samples were composited to 1m based on an analysis of sample lengths inside the wireframes. After review of the project statistics, it was determined that high grade cuts were required for Ag and V<sub>2</sub>O<sub>5</sub> within some domains.

The block model was created and estimated in Surpac using Ordinary Kriging ("OK") grade interpolation using parameters derived from modelled variograms in up to three passes. Linear grade estimation was deemed suitable for the Nxuu Mineral Resource due to the geological control on mineralisation.

The block dimensions used in the model were 15m NS by 15m EW by 5m vertical with sub-cells of 3.75m by 3.75m by 1.25m. This was selected as the optimal block size as a result of kriging neighbourhood analysis ("KNA").

A total of 513 bulk density measurements were taken on core samples collected from diamond holes drilled at the deposit using the water immersion technique. Bulk densities for the transitional mineralisation were assigned in the block model based on a density and zinc regression equation. Average densities for weathered mineralisation were applied (2.4t/m<sup>3</sup> for oxide). Average waste densities were assigned based on lithology and weathering.

## Cut-off Grade

The Statement of Mineral Resources has been constrained by the mineralisation solids and reported above a zinc equivalent ("ZnEq") cut-off grade of 0.5%. Zinc equivalent grades are estimated based on LME Zn/Pb prices, Kitco Silver Price for Ag, Live Vanadium Price for V<sub>2</sub>O<sub>5</sub>, Kitco Strategic Metals Prices for Ge/Ga, as at 21 October 2022. The ZnEq formula is shown below:

$$\text{ZnEq} = 100 \times [(Zn\% \times 3,000) + (Pb\% \times 2,000) + (Ag \text{ g/t} \times (20.0/31.1035)) + (V_2O_5\% \times 16,000)] / (3,000).$$

## Mining and Metallurgical Methods and Parameters

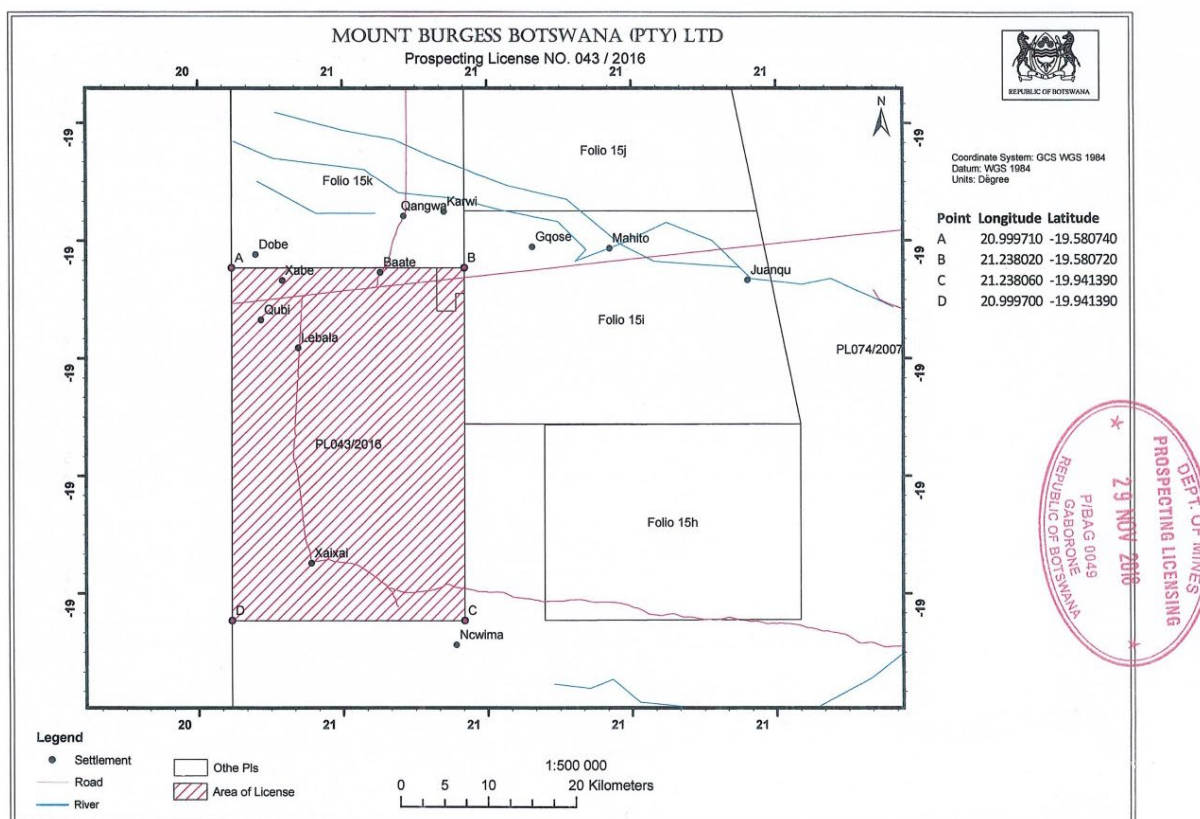
An open pit mining method is the most likely development scenario at Nxuu. Additional optimisation, mine design and more detailed and accurate cost estimate mining studies and test work are required to confirm viability of extraction.

The Nxuu mineralisation was initially determined to be a zinc and lead sulphide deposit. Metallurgical test work involved the recovery of the zinc / lead by flotation. Initial results gave low zinc recoveries (67.5%), with low sulphur in the tails.

Mineralogical evaluation of the tailings determined that the zinc was in an oxide form of baileychlore and the lead as a carbonate (cerussite). Further flotation tests were conducted, and the tailings subjected to leaching with sulphuric acid at 40° C for a zinc extraction rate of 89.5%.

Recovery of zinc concentrate by floatation and leaching of the zinc oxides (baileychlore) in the tailings resulted in a zinc extraction of 89.5% giving an overall access availability to 94% of zinc within the ore. Additional testwork is recommended.
