The Company advises that it has acquired the business of MQube Design from MQbd LLC for a consideration of USD121,064, of which USD33,898 has or will be paid by cash.

The MQube team has over 80 years of cumulative experience in Mechanical Engineering, Industrial Design, Project Management and Engineering Sales, with a strong emphasis in the consumer electronics field particularly in the development of laptops, desktop PCs, servers, printers, televisions, and handheld communications devices. Additionally, MQube's experience and contacts in the electronics industry will help to leverage opportunity identification for Intevia® intelligent fastening applications in this sector,

The balance of the purchase price is payable by the issue of 219,353 ordinary shares in the capital of TZ Limited at an issue price of \$0.65. 175,482 of these shares are to be issued today and the balance of 43,871 shares will be issued in 90 days time providing certain performance criteria are reached.
