ISSUE OF SHARE OPTIONS TO NEW AND EXISTING EMPLOYEES

Friday, December 17, 2004: USCOM Limited (ASX Code: UCM) announced today it had issued 269,000 share options in accordance with the USCOM Employee Share Option Plan.

The options, which over a 4 year period, were granted to new employees including Mr. Barry Zakar, USA Director of Operations and USCOM's new Medical Advisory Board member, Dr Karsten Knobloch, as well as existing employees reflecting their contribution to the achievements of USCOM during the past year.

USCOM now has a total of 1.124 million options outstanding, exercisable in accordance with the terms of USCOM Employee Share Option Plan. This represents 2.95% of total shares (38 million) outstanding. Please refer to the attached Appendix 3B for further information.
