Notice under section 708A(5)(e) of the Corporations Act 2001 (Cth)

VHM Limited (ASX: VHM) (the “Company”) is hereby giving notice under section 708A(5)(e) of the *Corporations Act 2001* (Cth) (“**Corporations Act**”).

The Company issued 2,000,000 fully paid ordinary shares (“**Shares**”) in accordance with the terms of its Investment Agreement with Bulk Commodity Holdings, LLC, which was announced to the market on 7 October 2024. An Appendix 2A with respect to the issue of the Shares was lodged by the Company today.
