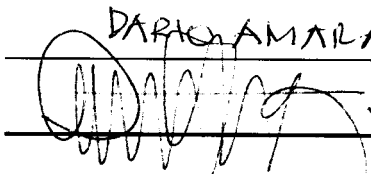

DIRECTIONS
