Directors' Report to shareholders for the half year ended 31 December 2021

The Directors present their report together with the financial report of WAM Research Limited for the half year ended 31 December 2021.

Directors

The following persons were Directors of the Company during the financial period and up to the date of this report:

Geoff Wilson AO (Chairman – Non-independent)

Kate Thorley (Director – Non-independent)

John Abernethy (Director – Independent)

Julian Gosse (Director – Independent)

Principal activity

The principal activity of the Company is making investments in listed companies. The Company's investment objectives are to deliver a stream of fully franked dividends and to achieve a high real rate of return, comprising both income and capital growth, within the risk parameters acceptable to the Directors. No change in this activity took place during the period or is likely to in the future.

Operating and financial review

Investment operations during the half year resulted in an operating profit before tax of \$16,898,493 (2020: \$44,642,707) and an operating profit after tax of \$12,341,305 (2020: \$31,724,250). The profit for the period is reflective of the solid performance of the investment portfolio over the six months to 31 December 2021. The investment portfolio increased 8.8% in the six months to 31 December 2021, outperforming the S&P/ASX All Ordinaries Accumulation Index by 4.2%. This outperformance was achieved with an average cash weighting of 7.1%.

The operating profit for the period includes unrealised gains or losses arising from changes in the fair value of the investments held in the investment portfolio during the period. This movement in the fair value of investments can add to or reduce the realised gains and losses on the investment portfolio and other revenue from operating activities (such as dividend and interest income) in each period. This treatment under the Accounting Standards can cause large variations in reported operating profits between periods.

The operating profit or loss for each financial period is reflective of the underlying investment portfolio performance and it is important to understand with context to the overall performance of equity markets in any given period. As a result, we believe the more appropriate measures of the financial results for the period are the investment portfolio performance, the change in net tangible assets (NTA) and fully franked dividends, together with total shareholder return.

WAM Research's NTA before tax increased 4.4% for the six months to 31 December 2021, including the 4.95 cents per share fully franked final dividend paid to shareholders during the period. This increase is after corporate tax paid of 3.7 cents per share or 3.0% of the Company's pre-tax NTA during the period. Corporate tax payments made throughout the period and performance fee accrued of 0.8% were the major item of difference between the investment portfolio increase of 8.8% and the NTA performance.

The franking credits attached to corporate tax payments are available for distribution to shareholders through fully franked dividends. Other items contributing to the change in the value of the assets during the period were management fees of 0.5% and other company related expenses of 0.2%, being offset by capital raising accretion of 0.1%.

The NTA before tax as at 31 December 2021 amounted to \$1.22 per share (June 2021: \$1.22). The NTA after tax was \$1.22 per share (June 2021: \$1.20). These figures are after the 4.95 cents per share fully franked final dividend paid to shareholders during the period.

The total shareholder return for the Company for the period to 31 December 2021 was 2.0%. This was reflective of WAM Research's solid investment portfolio performance, combined with the fully franked dividend paid during the period, offset by the slight decrease in the share price premium to NTA. As at 31 December 2021, the share price premium to NTA was 33.3% (June 2021: 34.9%). This measure does not value the potential benefit of franking credits distributed to shareholders through fully franked dividends.

A fully franked final dividend of 4.95 cents per share was paid during the period and a fully franked interim dividend of 5.0 cents per share has been declared by the Board and will be paid on 14 April 2022.

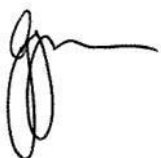

Notes to the financial statements for the half year ended 31 December 2021

1. Summary of significant accounting policies

These interim financial statements and notes for the half year represent those of WAM Research Limited.

The half year financial report was authorised for issue on 22 February 2022 by the Board of Directors.

Basis of preparation

The half year financial statements are general purpose financial statements that have been prepared in accordance with the requirements of the *Corporations Act 2001* and Australian Accounting Standard AASB 134: *Interim Financial Reporting*, as appropriate for for-profit oriented entities. Compliance with AASB 134 ensures compliance with International Financial Reporting Standard IAS 34: *Interim Financial Reporting*.

The half year report does not include full disclosures of the type normally included in an annual financial report. It is recommended that the half year financial report be read in conjunction with the Annual Financial Report for the year ended 30 June 2021 and any public announcements made by the Company during the half year in accordance with continuous disclosure requirements arising under the *Corporations Act 2001*.

Except for cash flow information, the financial statements have been prepared on an accruals basis and are based on historical cost with the exception of certain financial assets and liabilities that have been measured at fair value.

In accordance with ASIC Corporations (rounding in Financial/Directors' reports) Instrument 2016/191, the amounts in the financial report have been rounded to the nearest dollar, unless otherwise indicated.

The accounting policies have been consistently applied by the Company throughout the period and are consistent with those applied in the 30 June 2021 Annual Financial Report.

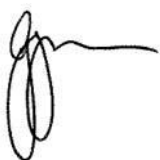

Report on the Half-Year Financial Report

Conclusion
