

CLEANSING NOTICE

This notice is given by West Coast Silver Limited (ASX:WCE) (“**WCE Silver**” or “**the Company**”) under section 708A(5)(e) of the *Corporations Act 2001* (Cth) (“**Corporations Act**”).

The Company advises that the issue of the following WCE Silver fully paid ordinary shares was completed and is detailed in the Appendix 2A lodged on ASX on 31 July 2026:

- 6,000,000 fully paid ordinary shares (“**New Shares**”) were issued upon conversion of performance rights.

The Corporations Act restricts the on-sale of securities issued without disclosure unless the sale is exempt under sections 708 and 708A of the Corporations Act. By the Company giving this notice, the issue of the New Shares set out above will fall within the exemption in section 708A(5) of the Corporations Act.

- (2) this notice is being given under section 708A(5)(e) of the Corporations Act;

 - (a) the provision of Chapter 2M of the Corporations Act as they apply to the Company; and
 - (b) section 674 and section 674A of the Corporations Act; and
- (4) as at the date of this notice, there is no information that is ‘excluded information’ (within the meaning of sections 708A(7) of the Corporations Act) which is required to be disclosed under section 708A(8) of the Corporations Act.
