A shortfall of 100,175,370 shares was announced on 7 February 2019. Winchester Energy Limited (**Winchester** or **Company**) issued 59,301,609 Shortfall Shares on 5 April 2019. The Shares were issued to sophisticated and professional shareholders at \$0.02 cents each and raised \$1,186,032 before costs.

The Company has issued a second tranche of 27,623,750 Shortfall Shares to professional and sophisticated investors to raise a further \$552,475 before costs. An Appendix 3B is attached to this notice.

Application for 13,250,000 of the Shortfall Shares has been made by Directors of the Company. These shares will only be issued subject to shareholder approval. It is anticipated that a notice of meeting will be mailed to shareholders shortly.

Secondary Trading Exemption

The Corporations Act 2001 ("**Act**") restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A. By the Company giving this notice, sale of the Securities noted above will fall within the exemption in section 708A(5) of the Act.

The Company hereby notifies ASX under section 708A(5)(e) of the Act that:

- (a) the Company issued the Securities without disclosure to investors under Part 6D.2 of the Act;
- (b) as at the date of this notice the Company has complied with the provisions of Chapter 2M of the Act as they apply to the Company, and section 674 of the Act; and
- (c) as at the date of this notice there is no information:
 - i. that has been excluded from a continuous disclosure notice in accordance with the ASX Listing Rules; and
