**OAMPS Ltd: 77.04% aggregate relevant interests and Institutional Acceptance
Collection Facility instructions**

We act for Wesfarmers Limited (**WES**) and its subsidiaries.

We refer to the off-market bid (**Offer**) by Wesfarmers Insurance Investments Pty Ltd (**WIPL**), a wholly owned subsidiary of WES, for all of the fully paid ordinary shares (**OAMPS Shares**) in OAMPS Ltd (**OAMPS**).

1. Notice of change of interests of substantial holder

On behalf of WIPL, we enclose a Notice of change of interests of substantial holder as required under section 671B of the Corporations Act.

2. Acceptance Facility

As advised previously, WIPL has established an Institutional Acceptance Collection Facility (**Acceptance Facility**) in relation to the Offer, under which certain "professional investors" (as defined in the *Corporations Act 2001* (Cth)) who hold OAMPS Shares may lodge acceptance instructions that demonstrate their intention to accept the Offer once the Offer is, or will become, unconditional. The Acceptance Facility is operated by ABN AMRO Corporate Finance Australia Limited (**ABN AMRO**).

ABN AMRO will deliver the acceptance instructions held in the Acceptance Facility once it has received a "Confirmation Letter" from WIPL. WIPL will not provide a Confirmation Letter to ABN AMRO unless:

- (a) the sum of the number of OAMPS Shares in which WIPL and its associates have a relevant interest at the relevant time; plus
- (b) the number of OAMPS Shares in respect of which acceptance instructions have been received (excluding any OAMPS Shares covered by paragraph (a)), as advised by ABN AMRO to WIPL,

is 70% or more of the number of OAMPS Shares on issue at that time.

Satisfaction of this requirement does not oblige WIPL to give the Confirmation Letter to ABN AMRO.

Provided that none of the conditions of the Offer have been breached and not waived, WIPL will provide the Confirmation Letter to ABN AMRO if:

- (c) the sum of the number of OAMPS Shares in which WIPL and its associates have a relevant interest at the relevant time; plus
- (d) the number of OAMPS Shares in respect of which acceptance instructions have been received (excluding any OAMPS Shares covered by paragraph (c)), as advised by ABN AMRO to WIPL,

is 90% or more of the number of OAMPS Shares on issue at that time.

3. **Facility Notice**

Also enclosed on behalf of WIPL is a notice (**Facility Notice**) dated 27 October 2006 provided by ABN AMRO in relation to the Acceptance Facility.

The Facility Notice discloses that, as at the date and time specified in the Facility Notice, 20,841,541 OAMPS Shares (representing 14.07% of the OAMPS Shares) are the subject of acceptance instructions in the Acceptance Facility. These acceptance instructions include 7,000,000 OAMPS Shares (representing 4.73% of the OAMPS Shares) in relation to which WES already has a relevant interest (and WIPL already has voting power) as a result of entry by WES into pre-bid and acceptance agreements (**Acceptance Shares**), details of which are contained in the enclosed Notice of change of interests of substantial holder.

Acceptance instructions deposited into the Acceptance Facility do not constitute acceptance of the Offer. Accordingly, except in relation to the Acceptance Shares, the OAMPS Shares in which WIPL or its associates have a relevant interest as disclosed in the Notice of change of interests of substantial holder do not include the OAMPS Shares the subject of acceptance instructions deposited with ABN AMRO in its capacity as acceptance collection agent under the Acceptance Facility.

The number of OAMPS Shares in which WIPL or its associates have a relevant interest (as disclosed in the Notice of change of interests of substantial holder), together with the number of OAMPS Shares the subject of acceptance

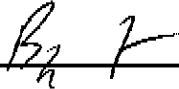

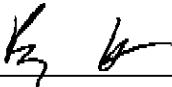

Acceptance instructions held by ABN AMRO Corporate Finance Australia Limited ABN 48 008 583 551 pursuant to Institutional Acceptance Collection Facility (Acceptance Facility)

ABN AMRO Corporate Finance Australia Limited ABN 48 008 583 551 (ABN AMRO) is acting as an acceptance collection agent for certain institutional shareholders (the Institutions) in OAMPS Ltd ABN 63 006 743 719 (OAMPS) in relation to the off-market bid (the Offer) by Wesfarmers Insurance Investments Pty Ltd ABN 63 105 168 876 (WIIPL) for all of the fully paid ordinary shares (OAMPS Shares) in OAMPS.

WIIPL has announced that (provided none of the conditions of the Offer have been breached and not waived) it will declare the Offer free from all unfulfilled conditions in the event that, on or before the close of the Offer period, WIIPL and its associates acquire a relevant interest in 90% or more of OAMPS Shares on issue at that time. WIIPL has reserved the right to do so in other circumstances subject to the Corporations Act. The Institutions may lodge with ABN AMRO acceptance instructions that demonstrate their intention to accept the Offer once ABN AMRO receives a letter (Confirmation Letter) from WIIPL confirming that either:

1. WIIPL has declared its Offer free from all conditions that have not been fulfilled; or
2. WIIPL will declare the Offer free from all conditions that have not been fulfilled once all of the instructions delivered into the Acceptance Facility have been validly processed or implemented (as appropriate).

WIPL has stated that it will not provide a Confirmation Letter to ABN AMRO unless the Confirmation Precondition has been satisfied. For this purpose, the Confirmation Precondition is:

- (a) the sum of the number of the OAMPS Shares in which WIPL and its associates have a relevant interest at the relevant time; plus
- (b) the number of OAMPS Shares in respect of which instructions have been received by ABN AMRO under the Acceptance Facility (excluding any OAMPS Shares covered by (a)), as advised by ABN AMRO to WIPL,

is 70% or more of the number of OAMPS Shares on issue at that time.

The instructions lodged with ABN AMRO by the Institutions may be withdrawn or amended at any time prior to the receipt by ABN AMRO of the Confirmation Letter.

As at 5pm on 27 October 2006, ABN AMRO advises that, in its capacity as an acceptance collection agent for the Institutions, it holds acceptance instructions in the Acceptance Facility for 20,841,041 OAMPS Shares (representing 14.07% of the OAMPS Shares). These acceptance instructions include 7,000,000 OAMPS Shares (representing 4.73% of the OAMPS Shares) in relation to which Wesfarmers Limited already has a relevant interest (and WIPL already has voting power) as a result of entry by Wesfarmers Limited into pre-bid and acceptance agreements.

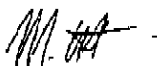

ABN AMRO also advises that:

- it does not have a relevant interest (as that term is defined in the *Corporations Act 2001* (Cth)) in any of the OAMPS Shares the subject of acceptance instructions held in the Acceptance Facility; and
- ABN AMRO and its related bodies corporate may have a relevant interest in OAMPS Shares which are not the subject of acceptance instructions held in the Acceptance Facility.

This notice has been provided by ABN AMRO to WIPL for provision to Australian Stock Exchange Limited in connection with the Offer.
