

MTD022 MINERALOGICAL WORK CONFIRMS ABUNDANT PENTLANDITE ADDENDUM

Western Mines Group Ltd (WMG or Company) (**ASX:WMG**) is pleased to provide shareholders with the attached addendum to yesterday's announcement (*ASX, MTD022 Mineralogical Work Confirms Abundant Pentlandite, 8 February*) on the results of mineralogical investigation work completed on samples from recent Phase 2 hole MTD022 at the Mulga Tank Ni-Cu-PGE Project, on the Minigwal Greenstone Belt, in Western Australia's Eastern Goldfields.

Information relevant to diamond drill hole MTD022, including JORC Tables, was previously presented in a drilling update on 14 December 2022 (*ASX, Nickel Sulphide Mineralisation Seen in Hole MTD022, 14 December 2022*). This was referenced in the announcement and should be referred to where necessary.

In compliance with *ASX Listing Rule 5.7*, necessary JORC Tables to aid shareholders with the understanding of the new exploration results in yesterday's announcement are provided below in this addendum to the announcement.

In compliance with *ASX Listing Rule 18.8*, descriptions of visual mineralisation and pXRF results are not a substitute for laboratory analysis. WMG will update shareholders when laboratory results become available.
