

SALE OF PERTH OFFICE

Iron Mountain Mining Ltd, ("Iron Mountain" or "the Company") (ASX: IRM) wish to advise that it has signed a formal contract for the sale of commercial property owned by the Company for \$900,000 (plus GST).

The sale of the Company owned office to a private investor is subject to Foreign Investment Review Board (FIRB) approval within 30 days of signing and final settlement within 60 days of FIRB approval.

This transaction is a continuation of the restructuring and rationalisation of the Company and its assets. Proceeds from this sale places Iron Mountain in a strong financial position for future value adding acquisitions given the current capital market conditions which have created attractive resource project investment opportunities.
