## UPDATED AND AMENDED DIRECTORS' INTERESTS NOTICES

Trinex Minerals Limited ("**Company**"), during the process of preparing the Appendix 3Ys - Change of Director's Interests Notices for the Directors participation in the Tranche 2 Placement, became aware of a discrepancy between the Directors' securities holdings and the previously released Appendix 3Ys for Mr Will Dix and Mr Stuart Crow. The Tranche 2 Placement settled on 2 July 2025.

Due to an administrative oversight, unlisted options with an exercise price of A\$0.011 and an expiry date of 21 December 2026 had not been included on previous Appendix 3Ys for these two Directors. The securities were issued on 21 December 2023.

The Company, through the release of the attached Appendix 3Ys, has immediately rectified this oversight.

The Company considers this oversight an isolated incident and believes it has adequate resources to comply with Listing Rule 3.19B.
