**Yandal Resources Limited ("YRL"): Appendix 3Y Change of Director's Interest Notice Query**

I refer to your letter dated 9 June 2022 in relation to the Appendix 3Y lodged by YRL on the ASX Market Announcements Platform on 8 June 2022 for Mr Gregory Richard Evans and Mr Timothy Kennedy. I provide the following responses to your queries:

**1. Please explain why the Appendix 3Y was lodged late.**

The Change of Director's Interest Notice was lodged late due to an administrative oversight. The Company took immediate steps to address this oversight on realisation that the Appendix 3Y had not been lodged within the prescribed period.

The subject of this query relates to changes in Mr Evans and Mr Kennedy's interests which occurred after shareholder approval on 19 May 2022. The change did not involve any on-market transactions and ASX was notified of the event via a release titled "Results of Meeting" on 19 May 2022 and an Appendix 3G titled "Notification regarding unquoted securities – YRL" on 20 May 2022.

**2. What arrangements does YRL have in place under Listing Rule 3.19B with its directors to ensure that it is able to meet its disclosure obligations under Listing Rule 3.19A?**

The Company has arrangements in place with its Directors that require the Directors to notify the Company of share transactions within 3 business days of any transactions. The Company's formal Securities Trading Policy and Continuous Disclosure Policy is available at [www.yandalresources.com.au](http://www.yandalresources.com.au). The notices were lodged immediately upon the oversight being identified.

**3. If the current arrangements are inadequate or not being enforced, what additional steps does YRL intend to take to ensure compliance with Listing Rule 3.19B?**

The Board believes that the current reporting arrangements are sufficient and ensure Directors are aware of their obligations to disclose all the information required by the Company to give ASX completed Appendix 3Y within the time period allowed by Listing Rules 3.19A and 3.19B.

**Yandal Resources Limited ('YRL'): Appendix 3Y – Change of Director's Interest Notice Query**

ASX refers to the following:

1. YRL's Appendix 3Y lodged on the ASX Market Announcements Platform ('MAP') on 8 June 2022 for Mr Gregory Richard Evans and Mr Timothy Kennedy (the 'Notice');
2. Listing Rule 3.19A which requires an entity to tell ASX the following:

3.19A.1 *'The notifiable interests of a director of the entity (or in the case of a trust, a director of the responsible entity of the trust) at the following times.*

- *On the date that the entity is admitted to the official list.*
- *On the date that a director is appointed.*

*The entity must complete Appendix 3X and give it to ASX no more than 5 business days after the entity's admission or a director's appointment.*

3.19A.2 *A change to a notifiable interest of a director of the entity (or in the case of a trust, a director of the responsible entity of the trust) including whether the change occurred during a closed period where prior written clearance was required and, if so, whether prior written clearance was provided. The entity must complete Appendix 3Y and give it to ASX no more than 5 business days after the change occurs.*

3.19A.3 *The notifiable interests of a director of the entity (or in the case of a trust, a director of the responsible entity of the trust) at the date that the director ceases to be a director. The entity must complete Appendix 3Z and give it to ASX no more than 5 business days after the director ceases to be a director.'*

3. Listing rule 3.19B which states that:

*'An entity must make such arrangements as are necessary with a director of the entity (or in the case of a trust, a director of the responsible entity of the trust) to ensure that the director discloses to the entity all the information required by the entity to give ASX completed Appendices 3X, 3Y and 3Z within the time period allowed by listing rule 3.19.A. The entity must enforce the arrangements with the director.'*

The Notice indicates that a change in Messrs Evans' and Kennedy's notifiable interest occurred on 19 May 2022. It appears that the Notice should have been lodged with ASX by 26 May 2022. Consequently, YRL may have breached Listing Rules 3.19A and/or 3.19B. It also appears that Messrs Evans and Kennedy may have breached section 205G of the *Corporations Act 2001* (Cth).

## Request for Information

Under Listing Rule 18.7, we ask that you answer each of the following questions having regard to Listing Rules 3.19A and 3.19B and *Guidance Note 22: Director Disclosure of Interests and Transactions in Securities - Obligations of Listed Entities*.

1. Please explain why the Appendix 3Y was lodged late.
2. What arrangements does YRL have in place under Listing Rule 3.19B with its directors to ensure that it is able to meet its disclosure obligations under Listing Rule 3.19A?
3. If the current arrangements are inadequate or not being enforced, what additional steps does YRL intend to take to ensure compliance with Listing Rule 3.19B?

## When and where to send your response

This request is made under Listing Rule 18.7. Your response is required as soon as reasonably possible and, in any event, by no later than **12:00 PM AWST Wednesday, 15 June 2022**. You should note that if the information requested by this letter is information required to be given to ASX under Listing Rule 3.1 and it does not fall within the exceptions mentioned in Listing Rule 3.1A, YRL's obligation is to disclose the information 'immediately'. This may require the information to be disclosed before the deadline set out in the previous paragraph and may require YRL to request a trading halt immediately.

Your response should be sent to me by e-mail at [ListingsCompliancePerth@asx.com.au](mailto:ListingsCompliancePerth@asx.com.au). It should not be sent directly to the ASX Market Announcements Office. This is to allow me to review your response to confirm that it is in a form appropriate for release to the market, before it is published on the ASX Market Announcements Platform.

## Trading halt

If you are unable to respond to this letter by the time specified above, you should discuss with us whether it is appropriate to request a trading halt in YRL's securities under Listing Rule 17.1. If you wish a trading halt, you must tell us:

- the reasons for the trading halt;
- how long you want the trading halt to last;
- the event you expect to happen that will end the trading halt;
- that you are not aware of any reason why the trading halt should not be granted; and
- any other information necessary to inform the market about the trading halt, or that we ask for.

We require the request for a trading halt to be in writing. The trading halt cannot extend past the commencement of normal trading on the second day after the day on which it is granted. You can find further information about trading halts in *Guidance Note 16 Trading Halts & Voluntary Suspensions*.

## Suspension

If you are unable to respond to this letter by the time specified above, ASX will likely suspend trading in YRL's securities under Listing Rule 17.3.

### **Listing Rules 3.1 and 3.1A**

In responding to this letter, you should have regard to YRL's obligations under Listing Rules 3.1 and 3.1A and also to Guidance Note 8 *Continuous Disclosure*: Listing Rules 3.1 – 3.1B. It should be noted that YRL's obligation to disclose information under Listing Rule 3.1 is not confined to, nor is it necessarily satisfied by, answering the questions set out in this letter.
